Baptist Convention of Iowa  
CONSTITUTION AND BY-LAWS

ARTICLE I, NAME

The name of this body is Baptist Convention of Iowa.

ARTICLE II, PURPOSE

It shall be the purpose of this Convention to offer an Agency of Cooperation for the churches and missions, to promote the preaching of the gospel in Iowa and throughout the world, to support ministerial and Christian education, to organize and promote all phases of work fostered by this Convention and the Southern Baptist Convention, and to aid any benevolent or moral movements it may deem promotive of God's Kingdom.

ARTICLE III, AUTHORITY

1. The Convention shall have ultimate control of any institutions that have been, or may be, acquired by or originated in this body.
2. The Convention shall choose for each institution a board of trustees, in number according to the charter of each institution, and fix their terms of service, reserving the right to change the terms of service of such trustees and to remove from office any and all of them at will. Boards of trustees and other agencies shall in everything be subject to the control of this Convention.
3. The Convention reserves the right, as plainly implied in the first section of this article, to effect a change in the charter of any of its institutions. Any institution which desires to amend its charter shall submit the proposed amendment in writing to the Convention for its approval, provided that the proposed changes be submitted in writing to the Convention on the first day of its meeting and be voted on the second day.
4. Trustees shall make such annual and special reports of their expenditures and of the state of their respective institutions as this Convention may require.
5. No trustee shall be paid a salary, fee, or commission by the institution he serves as trustee.
6. While independent and sovereign in its own affairs, this Convention recognizes the autonomy of churches and associations and disclaims all right of exercising authority over any church, association or any other Baptist institution not under the management of this Convention.

## ARTICLE IV, MEMBERSHIP

The Convention shall consist of messengers who are members of Baptist Churches and Missions cooperating with the Convention selected on either a numerical or financial basis. A cooperating church shall be defined as one participating in and contributing to the causes of the Baptist Convention of Iowa, i.e., cooperative program and missions giving. Each messenger shall be a member of the church which elects him/her.

1. On a numerical basis: two messengers shall be allowed from each cooperating church or mission of fifty members or less and one other messenger for every additional fifty members.
2. On a financial basis: one messenger shall be allowed from each cooperating church or mission for any part of the first two hundred dollars contributed to the work of the Convention, one additional messenger for the next five hundred dollars above the first two hundred dollars contributed to the work of the Convention, and one additional messenger for each two hundred dollars contributed to the work of the Convention above the first seven hundred dollars.
3. The messengers shall be elected and certified by the churches to the Convention with no church having more than ten (10) messengers.
4. The records as shown in the last published annual of the Baptist Convention of Iowa shall be used to determine the number of messengers from any one church.

## ARTICLE V, OFFICERS

1. The officers of the Convention shall be president, a first vice president, a second vice president, a secretary, and a treasurer.
2. All officers except the treasurer shall be elected at each annual meeting of the Convention, the president on the evening of the first day and the vice presidents in the same session or the morning session of the second day. Their term of office shall begin at the close of that annual convention.
3. The executive director-treasurer elected by the Executive Board of the Convention shall serve as the treasurer of the Convention.

4. The term of the office for the president is limited to two years, and he shall not be eligible for re-election until as much as one year has elapsed from the time his successor is named.
5. No employee of the Convention, its several institutions, agencies, or programs of work receiving compensation from the convention's budget shall be eligible to serve as president, 1st vice president, or 2nd vice president.
6. Officers of the Convention, officers and members of boards of trustees, and members of committees of the Convention shall hold membership in a church affiliated with and in cooperation with the Baptist Convention of Iowa.

#### ARTICLE VI, DUTIES OF OFFICERS

1. President: The duties of the president shall be to preside at all meetings of the Convention and serve as chairman of the Executive Board; while presiding at meetings, maintain order, decide all points of order except those appealed to the body, and to appoint the committee on committees. It shall be the president's privilege to speak as any other person, provided one of the vice presidents has been called to the chair. The president shall serve as ex-officio member of all committees, except when he chooses to ask one of the vice presidents to serve.
2. First Vice-President shall act in full capacity of president when the president is unable to fulfill the responsibilities or the office is vacant, or when the president chooses to invite the vice president to serve. The first vice president shall serve as ex-officio to the executive board.
3. Second Vice-President shall be available to preside when called upon by the President. The Second Vice-President shall act in full capacity of the First Vice-President when the First Vice-President is unable to fulfill the responsibilities or the office is vacant.
4. The Secretary shall record all proceedings of the Convention in session and the executive board in its meetings. The secretary shall keep a file of the minutes in a fireproof protection. This file constitutes the authentic record of the convention.
5. The Executive Director-Treasurer, elected by the executive board of the Convention, shall serve as treasurer of the Convention.
  - a) The treasurer shall receive and disburse the general and designated funds of the Convention as authorized by the Convention in session.
  - b) He shall have charge of invested and trust funds invest and disburse the same, collect and disburse interest thereon, subject in both cases

to instructions of the convention or of its administrative committee and the executive board.

- c) He shall make an annual report to the executive board for its approval and to the Convention for its approval of all receipts, disbursements, expenses and investments.
  - d) His books shall be audited/reviewed by a certified public accountant. A statement by the auditor/accountant concerning the audit/review and the Convention's business will be published in the minutes.
6. The President, First Vice-President, and Secretary shall constitute the Executive Officers of the Executive Board and shall have all the powers formerly entrusted to Trustees. However, nothing in this Constitution shall be deemed to require said Executive Officers to be held to the same legal standard as a Trustee to the extent that such legal standards exceed those that would be applicable to a corporate officer.

#### ARTICLE VII, THE EXECUTIVE BOARD

At the annual meeting the Convention shall nominate and elect an executive board of the Baptist Convention of Iowa.

- 1. The executive board of the Baptist Convention of Iowa shall consist of 21 regular members plus the president, first vice president, and secretary. One third shall be elected each year to serve a three-year term.
- 2. Two members shall be chosen from each association.
- 3. There shall be seven members chosen as at-large members which will properly represent more heavily populated areas of the state.
- 4. An effort shall be made to ensure balance between pastors and laity, and between male and female; however, the primary consideration for selection of executive board members shall be their expertise to serve effectively.
- 5. When vacancies occur between annual meetings of the convention, these may be filled upon recommendation of the executive board nominating committee and a two-thirds vote of the executive board present and voting.
- 6. All members of the board shall be members in good standing of Baptist churches which cooperate with the Convention in its programs of work and the Cooperative Program.

7. A member shall be elected for a term of three years and may be re-elected for a second three-year term. After a lapse of one year he may serve again if elected.
8. Nominees shall hold membership in a BCI affiliated church within the ministry area of an association at least one year before being eligible to serve on the Convention's executive board. Persons moving from an association or at large area to another shall vacate their position on the Board.
9. Members of the Executive Board may be removed in accordance with the Articles of Incorporation, Article IX.

#### ARTICLE VIII, DUTIES OF THE EXECUTIVE BOARD

1. The executive board shall be the executive, administrative, and promotional agency of the Convention and shall act under the instructions of the Convention, acting in its own capacity as a body through its administrative committee.
2. The executive board shall recommend to the Convention both a proposed goal or objective for raising funds, and a proposed distribution. The board shall promote all missionary, educational and benevolent causes of the Convention, and receive and disburse all funds according to the annual budget adopted by the Convention.
3. The executive board shall have authority to act, as a body or through its administrative committee, in all matters committed to it by the Convention and in matters which may arise between Convention sessions.
4. With the exception of the state office building, the executive board shall have authority to purchase, sell or lease property and to incur indebtedness necessary for the operation of the Convention. The state office building shall not be sold or leased without the approval of the messengers in an annual or called meeting.
5. It shall be the specific duty of each member of the board to promote the Convention's program in his/her respective area of the state.
6. A majority of the board shall constitute a quorum after every member has been notified sufficiently in advance.

#### ARTICLE IX, THE ADMINISTRATIVE COMMITTEE

1. The Convention shall elect the executive board annually. The president, first vice president, secretary and the chairpersons of the board's standing committees shall serve

as the Convention's administrative committee. The standing committees are: Evangelism and Ministries Committee, Missions Committee and Church Health Committee. Standing committees may be changed, added or deleted at the discretion of the executive board. The past president shall serve as ex-officio for one year following his term as president.

2. The president of the Convention shall serve as president of the administrative committee and the recording secretary shall serve as secretary.
3. Members of the administrative committee shall not receive compensation from the Convention budget, nor may members of their immediate families.

#### ARTICLE X, DUTIES OF THE ADMINISTRATIVE COMMITTEE

1. The administrative committee shall act under the authority of the executive board and/or the Convention in any matter committed to it by the board or by the Convention.
2. The committee shall act on any emergency administrative matter and its action shall carry the authority of the Convention, subject to review by the executive board.
3. The committee shall not involve the Board or Convention in financial obligations or project any major plans or work not authorized by the Board or the Convention.
4. A majority of the committee shall constitute a quorum after every member has been notified sufficiently in advance.
5. The administrative committee shall serve as the budget and audit committee for the Convention and shall meet with the executive director-treasurer to prepare the budget which is to be presented to the executive board in its September meeting and then the Board shall present the budget to the Convention in its annual session.

#### ARTICLE XI, ALTERATIONS

Any alterations may be made in these articles by a vote of two-thirds of the members present when the vote is taken without regard to the total enrollment at any annual meeting of the convention, provided that:

1. Any proposed amendment shall be presented in the book of reports and read on the first day of the Convention.
2. An amendment shall become effective upon approval by two successive Conventions.
3. The Bylaws may be changed by a simple majority vote in Annual Meeting.



**BYLAWS**  
**BYLAW I – DISBURSEMENTS**

1. All Cooperative Program receipts to the Convention shall be disbursed according to percentages or amounts approved by the Convention in its annual budget.
2. Special gifts - shall be applied according to the instructions of the donors in keeping with charitable contribution laws and the guidelines of the executive board and agency trustees.
3. Undesignated gifts - may be applied as the Convention wills.
4. The treasurer(s) of the Convention funds and institutions shall be bonded for faithful performance of duty, said bond(s) to be approved by the administrative committee of the executive board.

**BYLAW II – MEETINGS**

1. The Convention shall choose its meeting times and place.
2. The administrative committee of the executive board, when sufficient emergency arises as to time or place, may change the annual meeting either as to time or place or both.
3. Special meetings of the Convention shall be called by the president upon approval of the administrative committee. Those present, after at least a thirty-day notice has been presented by the president, shall constitute a quorum.
4. The Convention shall use the current edition of Roberts Rules of Order to guide its parliamentary procedures. A parliamentarian may be appointed by the president of the Convention.

**BYLAW III - CONVENTION COMMITTEES**

1. Committee on Committees:
  - a) Purpose: This committee shall serve to nominate members of those committees specifically related to the Convention. These committees shall include a Credentials Committee, Program Committee, Executive Board Nominating Committee, Constitution Review Committee, Resolutions Committee, History Committee and other continuing committees created by the Convention.

- b) Functions: Nominations for members on these committees, including a stipulation of which member shall be chair, shall be presented at the last session of the annual meeting of the Convention. After opportunity for nominations from the floor, these committees shall be elected by the Convention and shall serve from the conclusion of that Convention meeting.
- c) Composition and Selection: This committee of five (5) members shall be appointed by the president at the last session of the Convention and shall begin serving at the close of that session. Members shall be appointed for one year. The president shall stipulate which person shall serve as chair.

2. Credentials Committee:

- a) Purpose: This committee shall serve as the registration committee for the Convention's annual meeting.
- b) Function: As the Convention's registration committee during the annual meeting of the convention, this committee shall organize necessary procedures to affect the orderly certifying and seating of messengers. All questions of registration of messengers shall be referred to this committee. This committee shall make reports to the Convention as to numbers of messengers and guests registered.
- c) Composition and Selection: There shall be five (5) members of this committee on a rotating basis with members elected annually for three years.

3. Program Committee:

- a) Purpose: This committee shall plan and recommend the program for the annual meeting of the Convention.
- b) Function: This committee shall plan the next annual program sufficiently far in advance that provisional programs can be publicized to the constituency not less than one month before the scheduled meeting of that Convention. This committee shall recommend to the Convention the date and place of meeting for the next two (2) years. Previously published dates and places shall be used except when special reasons for changing are noted and approved by the Convention or the Executive Board.
- c) Composition and Selection: This committee shall be composed of five

(5) members elected to serve one (1) year.

4. Executive Board Nominating Committee:

- a) Purpose: It shall be the purpose of this committee to nominate members of the executive board, stipulating upon which of the three (3) committees they shall serve. It shall also be the responsibility of this committee to nominate the members of the Baptist Foundation Committee.
- b) Function: Annually, six (6) members shall be nominated for three (3) years for each of the three (3) committees of the executive board, in addition to the filling of vacancies. The committee shall nominate two (2) members each year for a three (3) year term for the Baptist Foundation Committee. The primary consideration of this committee shall be that those persons being nominated shall have special abilities or expertise that equips them to serve effectively in the area of their specified committee. An effort shall be made to see there is geographical representation as well as a balance between ministers and lay persons, and between male and female. Such concern for balance; however, shall not override concern for electing persons with skills to serve on the various committees. (Article VII, Executive Board)
- c) Composition and Selection: This committee shall be composed of six (6) members serving on a rotating basis, with two (2) elected annually for three (3) years.

5. Baptist Foundation Committee:

- a) Purpose: It shall be the purpose of this committee to serve the Baptist Convention of Iowa by receiving assets to be held and invested for the purpose for which they are received, i.e. scholarships, loan funds, mission funds. (Article II Section 2)
- b) Function: This committee shall receive and invest assets with the Executive Director-Treasurer serving as Chief Executive Officer working with the committee to serve Baptists in Iowa and the causes of Christ.
- c) Composition and Selection: This committee shall be composed of six (6) members serving on a rotating basis with two (2) being elected annually for a three year term. A member shall serve no more than two (2) three year terms until the lapse of at least one year. The members shall be nominated to the Convention by the Executive Board Nominating Committee.

6. Constitution Review Committee:

- a) Purpose: This committee shall review the constitution and by-laws for needed updating and revising, and shall receive referrals from the Convention.
- b) Function: This committee shall review the constitution and by-laws to be certain it is in harmony with the corporation charter and is consistent with all procedures and practices adopted by the Convention. This committee shall review and report to the executive board all motions for revision presented during the annual meeting of the Convention and/or to the executive board, with evaluations and recommendations ultimately being made to the Convention. This committee shall assist any messenger in presenting motions for revision to assure he shall be acquainted with proper procedures for amending the constitution and by-laws.
- c) Composition and Selection: This committee shall be composed of six (6) members serving on a rotating basis, with two (2) elected annually for three (3) years.

#### 7. Resolutions Committee:

- a) Purpose: This committee shall receive all resolutions presented to the Convention.
- b) Function: All resolutions shall be referred to the Resolutions Committee no later than the first session of the annual meeting of the Convention, although the committee shall not be bound to include resolutions which in the committee's evaluation will not contribute to the unity and advancement of the Convention in their final report unless instructed to do so by two-thirds vote of the Convention.
- c) Composition and Selection: This committee shall be composed of five (5) members elected for one (1) year.

#### 8. History Committee:

- a) Purpose: This committee shall be responsible for accumulating, indexing, and communicating to our constituency information about our history.
- b) Function: This committee shall bring to the attention of the Convention occasions when anniversaries or special events need to be commemorated. It shall print in the annual publication brief, updated

digests of the history of the Baptist Convention of Iowa.

- c) Composition and Selection: This committee shall be composed of three (3) members serving on a rotating basis with one (1) elected annually for three (3) years.

9. Baptist State Paper Committee:

- a) Purpose: This committee shall relate to matters pertaining to the Iowa Baptist.
- b) Function: This committee shall meet with the editor and serve as advisory council in matters of the publication of the state paper.
- c) Composition and Selection: This committee shall be composed of three (3) members serving on a rotating basis with one (1) elected annually for three (3) years. The members of this committee shall be nominated by the Committee on Committees.

Fifteenth Annual Convention  
Holiday Inn & Suites, Des Moines, Iowa  
November 5-6, 2010

The Community Southern Baptist Church Choir of Waterloo, led by Ann Davis, presented the music for this year's Annual Meeting. Choir members included Sarah Keys, Stephen Stevens, Mary Ann Reed, Joseph Shepherd, Miccah Mohorne, Brinesha McKinney, Iesha Campbell, Kaliyah Jones, Deont'e Smith, and Herb and Bette Thompson. The program opened with "I'd Rather Have Jesus," a heartwarming solo by Stephen Stevens.

Jimmy Barrentine, Baptist Convention of Iowa Executive Director-Treasurer, introduced the Convention Vice President, Eugene Guthrie, and the President, Ted Keys. He submitted himself to the President and presented him with the gavel at 6:05 p.m. Keys promptly called the meeting to order.

On behalf of the host church, Crestwood Baptist, Eugene Guthrie welcomed everyone to the 2010 Annual Meeting. He read Colossians 4:2-6, relating it to this year's theme, "Reach Out to Others," and then led in prayer.

Before asking for the Credentials Report, President Keys called attention to the printed announcement for "Bridges," to be held at Crestwood Baptist Church later this month on November 19-20. Marion Livingston then came to report that there were 119 Messengers present and 39 churches represented at this time, and he recommended that we seat the Messengers that have been and will be certified by the Credentials Committee throughout the course of the meeting. The recommendation was approved.

Keys presented a recommendation to accept the Program as printed and as may be adjusted by the president throughout the course of the meeting. Eugene Guthrie called for a vote to accept the recommendation, and it passed.

Moving to the Annual Report, Keys first invited everyone to take time to look at the President's Report on page 4 in the Book of Reports, and to review the Strategy Plan, the 2011 Proposed Budget, and the 2011 Calendar shown on pages 15-19. Then, briefly returning to the Program Committee report, Keys asked that the dates November 4-5, 2011, and November 2-3, 2012, be approved for the next two years' Annual Meetings, both to be held at the Holiday Inn and Suites in Des Moines; Guthrie called for a vote and the dates were approved. Guthrie then announced that the Annual Ministry Plan (pages 15-19) would be open for discussion and approval during the meeting tomorrow.

After Keys read the job description for the office of President, Vice President Guthrie called for nominations. Jay Hardyman nominated Ted Keys, with a second given by Robert Knight. Steve Nolting made a motion that nominations cease, seconded by Terry Wilkinson. Guthrie asked for a vote to cease the nominations and elect Ted Keys as President; the vote was unanimous.

Keys reviewed the primary responsibilities of the Secretary and asked for nominations. Terry Wilkinson nominated Jean Johnson. Robert Stout moved for motions to cease, followed by a second from Lloyd Eaken. Keys called for a vote on the motion to cease nominations; it passed. He then called for a vote to approve Jean Johnson as Secretary, and the vote was unanimous.

Guthrie announced that President Keys would be giving his message after the Community Southern Baptist Church Choir shared a time of music. He said the choir had been a blessing throughout the Ministers' Retreat, and expressed appreciation to them. He went on to pay tribute to Keys, describing him as a gracious, humble, and firm leader, and saying it was an honor to serve with him this past year.

The choir encouraged everyone to stand and join them in singing "I Love the Lord and I Won't Take It Back." They blessed everyone with two more songs, "I Love to Praise His Holy Name" and "Praise the Name of Jesus."

Before delivering his Presidential Address, Keys recognized Community Southern Baptist Church as a gracious place to work. He talked about how encouraged he was after he volunteered his church choir to sing at this year's Annual Meeting and they responded with enthusiasm. The theme he chose for his message was, "God's blessings upon you!" After expounding on difficult circumstances that can cause people to quit because it gets too tough, he read Isaiah 55:1-11 and led in prayer. Keys revealed that "God has a plan..." He said that God doesn't ask us to understand, He asks us to be faithful. He addressed the problem of "inward religion," and said God never told us to stay inside—he told us to go! "If you can't see the vision," Keys stated, "keep walking 'til you see it." He challenged us not to become discouraged and not to give up; whatever work you're doing, the devil doesn't like it. While it's up to the church to get the job done, it's up to God to add to the church. God rewards us for being faithful, so don't give up.

The closing prayer was given by Vince Goemaat, pastor of New Life Church, Knoxville, Iowa, and the meeting was dismissed by President Keys at 7:00 p.m.

The meeting reconvened Saturday morning at 8:05 a.m. The choir greeted everyone with a song led by Ann Davis, "Blessed Is the Man," and the congregation joined in singing, "Give Glory to God, Saints."

After President Keys called the meeting to order at 8:18 a.m., Herbert Thompson read Romans 8:30-37 and opened the meeting with prayer.

Before taking nominations for the First Vice President, Keys read the job qualifications written in the Book of Reports. Eugene Guthrie was nominated by Lloyd Eaken; Claude McFerron moved that nominations cease, seconded by Ken Kraft. A vote to cease nominations and elect Guthrie as First Vice President passed unanimously.

After Keys read the job qualifications for the Second Vice President, Eric Schumacher was

nominated by Tommy Rucker. Ryan Carpenter moved for nominations to cease, with a second given by John Sheeley. The vote to cease nominations and elect Schumacher was unanimous.

Keys invited Bob Rodgers to come and present the Southern Baptist Convention Executive Committee Report. Rodgers offered greetings to Barrentine, Keys, Staff Members and Messengers on behalf of the eighty-three members of the Executive Committee of the Southern Baptist Convention and Dr. Frank Page, the Committee's new President. He then reported that over the past decade Southern Baptists from Iowa have given over \$5,000,000.00 through the Cooperative Program, and he described how those funds have been used for international and North American missionaries, seminary students, and church planting. He noted the partnership Iowa Baptists have with the Tennessee Convention, and commended such cooperation between states to accomplish God's purpose. He expressed appreciation to Ted Keys for the previous night's sermon, saying that the message he preached is needed throughout the Southern Baptist Convention. As a word of encouragement, he read from 2 Corinthians 8:1-5, describing the poor condition of the Macedonians and commending their giving—they gave themselves first to the Lord. In summation, he said he appreciated the work being done in Iowa, the leadership to the churches given by Jimmy Barrentine, and the work done by the associational missionaries and ministers here. He encouraged everyone to keep up the good job they're doing for the Lord.

Vice President Guthrie asked that this year's new pastors and their wives come forward and introduce themselves. They included Luke Snowden, Corner Stone Baptist, Altoona; Herbert Thompson, New Beginnings Baptist Fellowship, Oelwein; Les Leftwich, Pioneer Southern Baptist, Denison; and Mike Brogan with his wife Diane, Memorial Baptist Church, Shenandoah. Following the introductions, Barrentine was invited to stand with the pastors while Guthrie offered a prayer on their behalf.

The Committee on Committees Report was given by Keys. Guthrie invited questions or additional nominations. Hearing none, the vote was taken and the report was approved by the Messengers.

Guthrie returned the gavel to Keys, and then submitted the following two Resolutions for approval:

After thanking members of the Nominating Committee for their service, he directed everyone's attention to a list of nominations for the Executive Board Nominating Committee, as printed on page 20 in the Book of Reports. After reading the list, he asked if there were any other nominations. Hearing none, Keys stepped forward to ask for the vote; the Messengers approved the nominations as printed. Next, Nolting read the names of nominees for the Baptist Foundation Committee (page 20) and asked if there were any other nominations. Again, hearing none, Keys asked Messengers to vote, and the Baptist Foundation Committee nominations were approved as printed.

President Keys called attention to the names of Executive Board Administrative Committee members appointed by him to serve on the Committee on Committees for 2011 (pages 20-21.)

Keys asked if there were any questions regarding the Annual Ministry Plan (pages 15-19) before adopting it. There were no questions, so he called for the vote. Approval was unanimous.

Barrentine gave the Executive Director's Address, acknowledging the President, Vice President and all the Messengers present, and thanking them for the privilege of working for and with them. Reading from Psalm 121, he opened his message with the assurance that "the one who keeps you shall neither slumber nor sleep." The good news is that no matter what difficulties we face, we can rest certain that the final sentence will read, "All is well." He emphasized the significance of the state of our relationship with one another and the state of our relationship with the Creator of heaven and earth. He asked us to affirm with him that we would keep that intact because it is holy and sacred before the Lord. In the context of such ministry, Barrentine acknowledged staff member John Shaull for ten years' service and Steve Murdock for five years' service with the Baptist Convention of Iowa, and affirmed our love and appreciation for them. He

called attention to his legal report on pages 22-23 in the Book of reports, the committee reports and notes of appreciation on pages 23-24, and the general financial reports on pages 26-29; also, he reported that we had a successful and commendable audit. Noting that the Foundation accounts are summarized on page 25, he expressed thankfulness for donors who are looking out for the future of God's work in Iowa. Focusing his message on the subject of change, Barrentine asserted that our future is in God's hands. He laid out his vision for the churches in Iowa, whether they be large or small; he shared his concerns regarding the needs of our pastors; he detailed the conditions necessary to support God's work in Iowa; and he listed guidelines that could be used to shape and mold our Convention to meet the needs of the churches. In closing, he declared that "It is time for change and we are ready for it."

Keys asked if there was any miscellaneous business that needed to be taken care of; none was presented. He called for the final report from the Credentials Committee. Marion Livingston thanked the hard-working members of his committee for their assistance, and then reported that we had 127 Messengers and 26 guests registered, with 48 churches represented. For the final music segment, the choir sang "Let's Lift Him Up" and then Davis taught the congregation a rhythmic African chorus, "Bambe Le La," meaning "Never Give Up."

President Keys introduced Richard Harris, and welcomed him as he came to deliver the Annual Sermon.

After first greeting Jimmy Barrentine and acknowledging other Baptist Convention of Iowa staff members, Harris commented on our Annual Meeting theme, "God's Plan for Sharing." He shared highlights from the Southern Baptist GPS program this year and revealed plans for future evangelism themes, explaining how they all relate to the Great Commission. Harris spoke on the theme "God's Plan for Sharing," first reading from 2 Corinthians 5:9-11 and then leading in prayer. He said that being successful and experiencing God's purpose in life and sharing the good news are not necessarily the same issue. The main points of his message were:

- God's Plan for Sharing includes a goal for living (verse 9)
- God's Plan for Sharing will be affirmed and rewarded at the judgment seat of Christ (verse 10)
- God's Plan for Sharing will be fulfilled when we understand we have an assignment in life. (verse 11)

He concluded by referring to the three words spoken during the ceremony performed at the Tomb of the Unknown Soldier, "Orders remain unchanged." Harris said that in spite of all that is happening in the world around us, in our conventions, our associations, and in our churches, he would like to say to Iowa Baptists, "Orders remain unchanged!"

At 10:25 a.m., President Keys passed the gavel back to Barrentine, and Madison Norrell closed the meeting with prayer.

## REPORTS OF THE EXECUTIVE BOARD

### President's Report

Ted Keys

It is a great honor you have given me to be able to share some of the thoughts that I have on my heart about our state Convention, our pastors, churches, all of our state staff, and our Executive Director-Treasurer that make up the Convention, up until this present hour.

I have been around a couple days so I can say: "I remember when." I am grateful for many things, especially for those of you who have been consistent in believing in the work that God has done, is doing, and will do.

God gave a vision long ago to those who came to this state with a vision, and they shared that vision with their churches, and they shared that vision with those who asked the question, "Who are those people called Southern Baptists?"

Today in some counties, they are asking the same question, and because of your willingness to persevere, the gospel is being heard. Our work is not yet done for there are many counties in the north east, north central, and the north west that have no, or very little, Southern Baptist work. Even in and around some of our major cities the harvest is ready for harvesting, and new church starts can **happen and will happen. We must never allow the words, "It cannot be done."**

The Executive Committee had an opportunity to review together Brother Jimmy's performance evaluation. We found that he met the high standard our Convention set; but also we appreciated the high standard he set for himself. Brother Jimmy seeks to lead by example, and that "example" is: to use every gift God has given, and every developed talent God has allowed, to further the work of ministry where we are.

When I heard him use the term "I will fight for you," it happened when the "Great Resurgence Task Force" information was released. He went to work and shared the information he had gathered, and traveled to persuade several of those involved to take a second look at how their decisions would affect pioneer states. This kind of attitude gives encouragement to many who believe in Kingdom Building, and who are working with all their heart to accomplish great things for this convention.

Again, I say thanks to all of you: to the state staff, who have been a blessing to me over these years; to the pastors in this Convention who have not lost the vision and are pressing on to the mark; and to all the churches for giving to the state and to the missions emphasis of the state. If I have left anyone out, to you too.

## **Report of the Programs of Work**

### Annual Report

Jimmy Barrentine, Executive Director-Treasurer

#### Appreciation

The entire Baptist Convention of Iowa staff joins with me in expressing gratitude to you and to God for the delight of serving you. You support us, counsel us, love us, pray for us and treat us with dignity and respect. Thank you, Iowa Baptists.

#### State of the Convention

The Annual Church Profile and staff reports provide an objective perspective of the Convention's health. Selected highlights are presented in order to praise God and highlight the work of the churches. Your staff does not deserve and does not seek credit for what the Father and his churches have done.

Unless otherwise indicated, the following statistics are based on the 2008 and 2009 reporting years because the final 2010 statistics are not currently available.

Gifts to missions reflect the sacrificial giving of God's people in days of financial strain. For example, the Cooperative Program gifts were up by 2.3% as we moved into 2010. To date they are down slightly for the current year. State missions offerings are up. Gifts to international missions are up and gifts to North American missions are down.

The heartbreak in this year's report is that baptisms were down by 7.9% as we moved into 2010. The consolation is that the churches baptized 527 people in 2009. The expectation is that they will be up in 2010. The foundation for that hope is the work the Lord has done through God's Plan for Sharing. Commonly referenced as GPS, God's Plan for Sharing engaged the churches in an evangelistic effort that effectively scattered the gospel seed across our state.

There were 8 new churches started since last November of 2009.

In 2010, Iowa Baptists made 71 project requests to the Tennessee Baptist Convention. Of those 40 were filled. Iowa Baptists completed at least 2 projects in Tennessee. Baptist Builders completed 2 projects in Iowa. Campers on Mission also completed 2 projects in Iowa.

Sunday school attendance was up by 8.1% and Sunday morning worship was up by 3.4% as we moved into this year. Initial reports give us reason to hope that the same will be true for 2010.

More than 11,029 people were fed through hunger ministries since last November. Some 5,977 people received ministry through the Friendship Baptist Center. Just over 2,873 adults, children and youth attended various Bible studies and Bible Clubs at the Center.

### Staff Recognitions

Every member of the staff deserves special recognition each and every year. A point of praise is that the Father has tended to loan them to us on a long-term basis, thus sparing us of the turnover experienced in some conventions. Those celebrating employment anniversaries this year are John Shaull, ten years, and Steve Murdock, five years. It is a pleasure to commend both of these men for their work.

We lost only one staff member this year. The Father continued his healing work in the life of Jenifer Barrentine, consultant for partnership missions and human services. She moved to a job in Mississippi. Her mother, Joan Barrentine, has stepped in and filled the gap left by Jenifer's departure.

### Financial Report

The detailed financial report can be found on Pages 16-17. The essential summary is that we are not broke or running red. Again, that is due to the sacrificial gifts of Iowa Baptists and to the beneficence of our Southern Baptist partners.

### Committee Reports

A brief report on the superb work done by the committees follows:

*Credentials Committee (Marion Livingston, Chair, Ross Harmonson, David Church, Sarah Keys, Robert Knight):* The Credentials Committee is the workhorse committee. It examines and recommends the seating of messengers to the Annual Meeting, thus protecting the legal life of the Convention. It examines the doctrinal views and tests the missions commitment of churches seeking affiliation with the Convention. This committee does its work smoothly and effectively. Its long-term chairman, Marion Livingston of Cedar Rapids has been used of God to make that so.

*Program Committee (Convention President, Pastors' Conference President, Pastors' Conference Vice President, Executive Director's Wife, Administrative Secretary):* You will not hear a lot from them in this meeting, but the Program Committee planned every aspect of the Annual Meeting. They selected the preacher. They selected the music leaders. They developed the format for the meeting seeking to assure that all that is done is done within the context of worship. They also recommend future sites for the Annual Meeting.

*Executive Board Nominating Committee (Steve Nolting, Chair, Eric Schumacher, Claude McFerron, Chuck Kizer, Woodie Ladnier, Chuck Spindler, Arnaldo Achucarro) and Committee on Committees (Ted Keys, Chair, Eugene Guthrie, Jean Johnson, Jeff Wheeler, Lloyd Eaken, Gary Fry, Jay Anderson):* With the exception of officers elected in the Annual Meeting, these committees work together to compile the list of persons recommended to serve on the Executive Board and every committee of the Convention. These committees complete their annual assignment only through prayer and hard work. They do their work with two principles in mind.

Simply stated, those statements are: 1) We do not reward or punish. 2) We seek to discover God's choices for Convention leadership. The result of their 2010 work can be found on Pages 20-21.

*Constitution Review Committee (Paul Porter, Chair, Mitch Green, Dennis Bradley, John Moles, Richard Lamborn, Stan Rankins):* This committee performs an essential task. It reviews the Convention's Constitution and Bylaws seeking to keep them in harmony with current legal standards and in harmony with the decisions and directives of the messengers to the Annual Meeting.

*History Committee (David Brown, Chair, Joe Needham, Willard Smith):* The primary task of this committee is not the collection of, or preservation of, historical trivia and mementos. We have a collection of both, but the primary task of this committee is the preservation of the Convention's guiding and legal documents. The Articles of Incorporation, the Constitution and Bylaws, the messenger cards, the essential business records, the minutes of the Annual Meeting, and the minutes of the Executive Board meetings are all held in custody under the direction of this committee.

*Iowa Baptist Committee (Jeff Wheeler Chair, Paul Porter, Todd Stiles):* This committee reviews the effectiveness of the Convention's newspaper. It is currently seeking to find a paper format that will result in serving the churches even better at a lower cost. One option before the committee is a reduction in pages, from twelve to eight pages.

*Baptist Foundation Committee (Mike Carlson, Chair, Bob Scott, Sandy Guthrie, Joyce Hardymon, Louise Lorenz, Terry Wilkinson):* The Foundation Committee is the second workhorse. The committee's financial report is found on Pages 24-29. The information found in the report is subject to the end of year audit.

The funds managed by the Foundation Committee are:

**Irene McFerron Small Church Fund:** This fund provides maintenance and repair grants to small churches and missions.

**Lindberg-McFerron Scholarship Fund:** This fund provides scholarships for students preparing for ministry. This fund has been very active in 2009. Had a new donor not stepped forward, there would not have been sufficient funds available for distribution in 2010. We thank God for calling Iowans to ministry and we thank God for donors ready to help them acquire a quality education.

**Non-interest Bearing Loan Fund:** This fund helps to meet critical needs by providing small non-interest bearing loans.

**Kier Memorial Fund:** This fund helps to under gird the Convention's on-going Cooperative



Program budget.

Barnes New Work Fund: This fund provides funding for starting new churches and new ministries.

Hamilton Collegiate Missions Fund: This fund helps college students engage in North American Mission Board and International Mission Board projects.

The information presented represents current information available on August 31, 2010. Variations in the report would be due to outstanding accrued interest, reclassifying journal entries, and other such information that may arise during the year-end audit. The Baptist Convention of Iowa makes every effort to preserve donor intent for Kingdom purposes.

God has been really good to Iowa Baptists so far in 2010. Below are a few of the highlights of how God has been working in Iowa in 2009 and so far in 2010:

- There are eight new church starts underway in the state so far in 2010. In Gowrie there is a lay-led Bible study designed to become a new church. In Webster City there is an evangelistic Bible study for Laotians. In Iowa City, there is a collegiate-based church plant called “Veritas” led by a church planting team from Cornerstone, Ames. There are also church plants in Ames (house church), Davis City, a Liberian church plant in Des Moines, a multicultural church plant called New Beginnings Baptist Church in Oelwein and another multicultural church plant called Light of the World Church in Waterloo.
- Missions education is part of the missions team’s assignment, so we always promote all three missions offerings and prayer emphases. In 2009, Cooperative Program giving was up by 2.2 percent, Lottie Moon up by 29.2 percent, Annie Armstrong up by 7 percent and the Hyde State Missions Offering was down 19 percent over 2008 numbers. According to the 2009 Annual Church Profile, total missions project participation was up 1.5 percent over 2008 numbers. Local projects were up 39 percent, and projects in North America were up 19 percent.
- In the area of partnership missions, the Iowa-Tennessee Missions Connection will officially come to an end December 31, 2011. So far in 2010, 87 project requests for Iowa have been made and 65 of them have been filled. Thirty-six have been filled by Tennessee churches and 14 filled by churches from other states. In 2010, 15 mission projects were filled by Iowa churches or entities, which is an all-time record! Most importantly, 77 professions of faith have been recorded so far in this year’s partnership missions.
- The annual church planter training this year is scheduled to take place October 23 at Cornerstone Baptist Church in Ankeny. This year’s theme will be Starting and Multiplying Lay-Led Evangelistic Small Groups *That May Lead to New Churches*, led by Lyle Seltmann of the North American Mission Board. Quarterly Church Planter Network fellowships are also provided for BCI-affiliated church planters.
- In the area of multicultural ministry, there are currently seven Korean churches, five Hispanic congregations, two multicultural congregations, one Liberian church plant, one Laotian church plant, and ministries to Nepalis and Afghans.
- Total WMU participation in the state was up in 2009 by 50 percent, and total mission expenditures in our churches was up almost 23 percent. In spite of a struggling economy, Iowa Baptists are still active in giving to and participating in missions.

Thank you for your prayers and involvement in Baptist missions in Iowa.

We are entering the first year of a 10 year commitment called GPS (God's Plan for Sharing) emphasis that embraces (1) Abiding in Christ, (2) Holding to One Another, (3) Reaching out to Others. This year has opened up opportunities for Iowa to introduce and train in a new directional approach of evangelism called GPS, (God's Plan for Sharing) that networks with Church Planting and Church Health to take the Gospel to every person in Iowa.

Summer and Semester Missionaries: This has been an outstanding year with these student missionaries coming from MS, FL, TN, and IA. It is an honor to invest with these young people coming to serve in mission ministry across Iowa. We had a total of 12 students, including our Semester missionaries, serving in 2010.

Disaster Relief: Several regional training events were hosted by Iowa local churches. Our Annual State Wide Training Event was held at Crestwood Baptist church-Des Moines. The event focused on training, chaplaincy, updating and mobilizing Iowa Southern Baptist for deployment. We had 72 people attending Disaster Relief training this year. The Baptist Convention of Iowa hosted the NAMB mobile command unit, set up at Corner Stone-Altoona, serving central Iowa flood victims. The following states assisted Iowa Baptist Disaster Relief in flood recovery assistance: NM, MO, and IL, IN, AL, KY, MI, GA, and NE/KS. NW/SW Chainsaw Unit in western Iowa had several call out jobs in Western Iowa, and nearby neighboring states. Iowa Churches shared in over 300 Buckets of Hope for Haiti.

Baptisms: Baptisms across Iowa increased by 3.8% More than 50% of BCI churches participation in GPS. We continue pray and witness with the local church to reach their community for Christ. During 2009 several churches have conducted and or scheduled training events that introduced intentional evangelism through the local church.

General Evangelism Training: BCI-Evangelism, partnering with each association to train Iowans in personal evangelism during 2010. Each association increased in personal evangelism training from the previous year. Regional Associational Evangelism Conference in each Association helps training and encourages our churches in intentional evangelism.

Baptist Men/Boys Ministries: Our state-wide men's retreat held at the Y-training Conference Center saw 134 men gather under the banner of GPS (God's Plan for Sharing through Men) with Thomas Hammond leading this retreat. Reggie Lafaye led our music and taught in breakout



sessions. Men's Ministries across Iowa have increased by 19.1%

Next Level Leadership Network: We saw a continued growth in leadership development through Next Level Leadership workshops. These growth development seminars were held with search committees, church leadership teams, deacons, and pastors.

Youth Evangelism/Leadership: Growing number of churches participated in the Ignite Conference for Youth Leadership Training. We witnessed one of the largest gatherings of youth for Impact University (Youth Evangelism/Discipleship week for youth). A growing number of parents and their youth participated in the Prayer Journal, a prayer time for their public schools and administrators.

Literature Distribution: The BCI Evangelism team gave out over 4309 Bibles, 300,900 witnessing tracts, 1200 New Testaments, and host of other training materials designed to equip and educate believers to be intentional in sharing Christ.

Church Health Team  
Richard Nations, Team Leader

This year I focused on consulting with churches, working with new church starts to help get them off to a healthy beginning, working with the associations to promote and encourage Vacation Bible School and to enlist some more people to become involved in writing for the "Iowa Baptist" newspaper and development of the Iowa Baptist website [www.bciowa.org](http://www.bciowa.org).

I am happy to report that most of the goals I set at the beginning of the year are on track to be fulfilled. And we are seeing a positive trend in the statistics for many areas of church life this year.

Measuring 2008 and 2009 Annual Church Profile statistics, we saw increases in Sunday school enrollment (8%), while Sunday school average attendance had only a slight increase (2%). Small group Bible studies increased a whopping 29% though! Discipleship training participation increased as well (10%). Many churches are starting groups that meet at many different times and locations in addition to or instead of the Sunday school hour right before the Sunday morning worship time. Whenever you have Bible study groups or do discipleship training, I hope you give it your best and use good curriculum that points people to Jesus.

Worship attendance showed only a slight increase (3%) and resident membership for the churches statewide showed a small increase (4%). Total membership statistics for Iowa churches was down 1%.

I almost decided to leave out the VBS statistics because they showed a pretty dramatic decrease! Comparing 2009 to 2008 there was a 23% decrease in VBS enrollment and professions of faith were down 27%. But I am glad to see that for the year to date so far in 2010 the VBS enrollment is up considerably (8%) and the number of professions of faith in VBS has increased 65% -- 136

kids got saved in VBS in 2010 (as currently reported). So that's good news.

Now if you are still with me after all these statistics I've been rattling off, well, I'm proud of you for being loyal. I understand this is not the most exciting reading.

Thom Rainer and Ed Stetzer say in their book "Transformational Church" that the evangelical churches that are growing in North America today are "creating a new scorecard for congregations." Stetzer says, "We believe one of the most important measurements is ensuring that men and women are being changed by the power of the gospel." The book follows that statement with suggestions for new kinds of measurements, some of which are beyond what the standard Annual Church Profile measures. They suggest we focus on: missional mentality, vibrant leadership, relational intentionality, prayerful dependence, worship that embraces Jesus, community that connects people and mission activity connecting words about Jesus with action. I am sure you will hear a lot about "Transformational Church" from our staff in the days to come as we are using the research to impact the way we do consultations with churches. In the end, we want to see your church succeed and grow and people's lives being transformed by the power of the Gospel.

Our training team: Ted Keys (Sunday school), Chuck Spindler (adults), Tammy Proenneke (youth), Dianna Sparks (children/preschool) and Rachel Nations (special needs) are always willing to help you. We are available for training, consultations or resources. I work closely with the directors of missions to do church process consultations where we take a good long look at every area of church life and help the church leadership team develop a fresh ministry plan and strategy. We are here to serve and it is our pleasure to assist you in church health ministry.

#### Associational Missions Team Leader Report John Shaull

My responsibilities fall under three basic categories. They are: Associational Missions, Impact University and Baptist Collegiate Ministry.

**Associational Missions:** Our Associational Missionaries/Church Starter Strategists continue to be engaged in strengthening and starting churches throughout the state. I believe the total starts for this year are eight. All Associational Missionaries are now trained in Church Consultation and are available if your church wants to have your associational missionary assist you with an overview of your church's goals, plans and ministries. Remember to pray for your missionary and his family.

**Impact University:** The best way to tell you about Impact University is for you to hear what our students said: Kristian said: "This is the best camp I've ever attended. It means a ton to me." Allison writes: "This was my 5<sup>th</sup> year and my first as a family leader. It is always the highlight of my summer. Thanks for letting God use you in providing a great camp to Iowa youth." Kourtney stated: "Impact is a week to step back and evaluate my walk with Christ and discern where I'm at

and through relationships with others to be encouraged in my walk with Christ.” We had a record 172 students and 52 staff for a total of 224. There were seven salvations reported, sixteen rededications and seven commitments to vocational Christian ministry.

**Baptist Collegiate Ministry:** Salt Company in Ames sent out a group of nearly 50 students and staff from Iowa State to Iowa University this year to start a new collegiate ministry in Iowa City as well as a new church named “Veritas”-Truth. They have begun their new work in Iowa City and are moving forward. Herbert Thompson has also begun a new Baptist Collegiate Ministry in Oelwein on the Upper Iowa campus. That means we now have a total of 6 collegiate ministries state wide. In the past year our collegiate ministries reported 85 professions of faith in Christ, total participants of 750 students and 125 students who went on short term mission trips. Please pray for our campus ministries in Dubuque, Oelwein, Ames, Iowa City (2) and Des Moines.
