Baptist Convention of Iowa CONSTITUTION AND BY-LAWS

ARTICLE I, NAME

The name of this body is Baptist Convention of Iowa.

ARTICLE II, PURPOSE

It shall be the purpose of this Convention to offer an Agency of Cooperation for the churches and missions, to promote the preaching of the gospel in Iowa and throughout the world, to support ministerial and Christian education, to organize and promote all phases of work fostered by this Convention and the Southern Baptist Convention, and to aid any benevolent or moral movements it may deem promotive of God's Kingdom.

ARTICLE III, AUTHORITY

- 1. The Convention shall have ultimate control of any institutions that have been, or may be, acquired by or originated in this body.
- 2. The Convention shall choose for each institution a board of trustees, in number according to the charter of each institution, and fix their terms of service, reserving the right to change the terms of service of such trustees and to remove from office any and all of them at will. Boards of trustees and other agencies shall in everything be subject to the control of this Convention.
- 3. The Convention reserves the right, as plainly implied in the first section of this article, to effect a change in the charter of any of its institutions. Any institution which desires to amend its charter shall submit the proposed amendment in writing to the Convention for its approval, provided that the proposed changes be submitted in writing to the Convention on the first day of its meeting and be voted on the second day.
- 4. Trustees shall make such annual and special reports of their expenditures and of the state of their respective institutions as this Convention may require.
- 5. No trustee shall be paid a salary, fee, or commission by the institution he serves as trustee.
- 6. While independent and sovereign in its own affairs, this Convention recognizes the autonomy of churches and associations and disclaims all right of exercising authority over any church, association or any other Baptist institution not under the management of this Convention.

ARTICLE IV, MEMBERSHIP

The Convention shall consist of messengers who are members of Baptist Churches and Missions cooperating with the Convention selected on either a numerical or financial basis. A cooperating church shall be defined as one participating in and contributing to the causes of the Baptist Convention of Iowa, i.e., cooperative program and missions giving. Each messenger shall be a member of the church which elects him/her.

- 1. On a numerical basis: two messengers shall be allowed from each cooperating church or mission of fifty members or less and one other messenger for every additional fifty members.
- 2. On a financial basis: one messenger shall be allowed from each cooperating church or mission for any part of the first two hundred dollars contributed to the work of the Convention, one additional messenger for the next five hundred dollars above the first two hundred dollars contributed to the work of the Convention, and one additional messenger for each two hundred dollars contributed to the work of the Convention above the first seven hundred dollars.
- 3. The messengers shall be elected and certified by the churches to the Convention with no church having more than ten (10) messengers.
- 4. The records as shown in the last published annual of the Baptist Convention of Iowa shall be used to determine the number of messengers from any one church.

ARTICLE V, OFFICERS

- 1. The officers of the Convention shall be president, a first vice president, a second vice president, a secretary, and a treasurer.
- 2. All officers except the treasurer shall be elected at each annual meeting of the Convention, the president on the evening of the first day and the vice presidents in the same session or the morning session of the second day. Their term of office shall begin at the close of that annual convention.
- 3. The executive director-treasurer elected by the Executive Board of the Convention shall serve as the treasurer of the Convention.
- 4. The term of the office for the president is limited to two years, and he shall not be eligible for re-election until as much as one year has elapsed from the time his successor is named.
- 5. No employee of the Convention, its several institutions, agencies, or programs of work receiving compensation from the convention's budget shall be eligible to serve as president, 1st vice president, or 2nd vice president.

6. Officers of the Convention, officers and members of boards of trustees, and members of committees of the Convention shall hold membership in a church affiliated with and in cooperation with the Baptist Convention of Iowa.

ARTICLE VI, DUTIES OF OFFICERS

- 1. President: The duties of the president shall be to preside at all meetings of the Convention and serve as chairman of the Executive Board; while presiding at meetings, maintain order, decide all points of order except those appealed to the body, and to appoint the committee on committees. It shall be the president's privilege to speak as any other person, provided one of the vice presidents has been called to the chair. The president shall serve as ex-officio member of all committees, except when he chooses to ask one of the vice presidents to serve.
- 2. First Vice-President shall act in full capacity of president when the president is unable to fulfill the responsibilities or the office is vacant, or when the president chooses to invite the vice president to serve. The first vice president shall serve as ex-officio to the executive board.
- 3. Second Vice-President shall be available to preside when called upon by the President. The Second Vice-President shall act in full capacity of the First Vice-President when the First Vice-President is unable to fulfill the responsibilities or the office is vacant.
- 4. The Secretary shall record all proceedings of the Convention in session and the executive board in its meetings. The secretary shall keep a file of the minutes in a fireproof protection. This file constitutes the authentic record of the convention.
- 5. The Executive Director-Treasurer, elected by the executive board of the Convention, shall serve as treasurer of the Convention.
 - a) The treasurer shall receive and disburse the general and designated funds of the Convention as authorized by the Convention in session.
 - b) He shall have charge of invested and trust funds, invest and disburse the same, collect and disburse interest thereon, subject in both cases to instructions of the convention or of its administrative committee and the executive board.
 - c) He shall make an annual report to the executive board for its approval and to the Convention for its approval of all receipts, disbursements, expenses, and investments.
 - d) His books shall be audited/reviewed by a certified public accountant. A statement by the auditor/accountant concerning the audit/review and the Convention's business will be published in the minutes.

6. The President, First Vice-President, and Secretary shall constitute the Executive Officers of the Executive Board and shall have all the powers formerly entrusted to Trustees. However, nothing in this Constitution shall be deemed to require said Executive Officers to be held to the same legal standard as a Trustee to the extent that such legal standards exceed those that would be applicable to a corporate officer.

ARTICLE VII, THE EXECUTIVE BOARD

At the annual meeting the Convention shall nominate and elect an executive board of the Baptist Convention of Iowa.

- 1. The executive board of the Baptist Convention of Iowa shall consist of 21 regular members plus the president, first vice president, and secretary. One third shall be elected each year to serve a three-year term.
- 2. Two members shall be chosen from each association.
- 3. There shall be seven members chosen as at-large members which will properly represent more heavily populated areas of the state.
- 4. An effort shall be made to ensure balance between pastors and laity, and between male and female; however, the primary consideration for selection of executive board members shall be their expertise to serve effectively.
- 5. When vacancies occur between annual meetings of the convention, these may be filled upon recommendation of the executive board nominating committee and a two-thirds vote of the executive board present and voting.
- 6. All members of the board shall be members in good standing of Baptist churches which cooperate with the Convention in its programs of work and the Cooperative Program.
- 7. A member shall be elected for a term of three years and may be re-elected for a second three-year term. After a lapse of one year he may serve again if elected.
- 8. Nominees shall hold membership in a BCI affiliated church within the ministry area of an association at least one year before being eligible to serve on the Convention's executive board. Persons moving from an association or at large area to another shall vacate their position on the Board.
- 9. Members of the Executive Board may be removed in accordance with the Articles of Incorporation, Article IX.

ARTICLE VIII, DUTIES OF THE EXECUTIVE BOARD

- 1. The executive board shall be the executive, administrative, and promotional agency of the Convention and shall act under the instructions of the Convention, acting in its own capacity as a body through its administrative committee.
- 2. The executive board shall recommend to the Convention both a proposed goal or objective for raising funds, and a proposed distribution. The board shall promote all missionary, educational and benevolent causes of the Convention, and receive and disburse all funds according to the annual budget adopted by the Convention.
- 3. The executive board shall have authority to act, as a body or through its administrative committee, in all matters committed to it by the Convention and in matters which may arise between Convention sessions.
- 4. With the exception of the state office building, the executive board shall have authority to purchase, sell or lease property and to incur indebtedness necessary for the operation of the Convention. The state office building shall not be sold or leased without the approval of the messengers in an annual or called meeting.
- 5. It shall be the specific duty of each member of the board to promote the Convention's program in his/her respective area of the state.
- 6. A majority of the board shall constitute a quorum after every member has been notified sufficiently in advance.

ARTICLE IX. THE ADMINISTRATIVE COMMITTEE

- 1. The Convention shall elect the executive board annually. The president, first vice president, secretary and the chairpersons of the board's standing committees shall serve as the Convention's administrative committee. The standing committees are: Evangelism and Ministries Committee, Missions Committee and Church Health Committee. Standing committees may be changed, added or deleted at the discretion of the executive board. The past president shall serve as ex-officio for one year following his term as president.
- 2. The president of the Convention shall serve as president of the administrative committee and the recording secretary shall serve as secretary.
- 3. Members of the administrative committee shall not receive compensation from the Convention budget, nor may members of their immediate families.

ARTICLE X, DUTIES OF THE ADMINISTRATIVE COMMITTEE

- 1. The administrative committee shall act under the authority of the executive board and/or the Convention in any matter committed to it by the board or by the Convention.
- 2. The committee shall act on any emergency administrative matter and its action shall carry the authority of the Convention, subject to review by the executive board.
- 3. The committee shall not involve the Board nor Convention in financial obligations or project any major plans or work not authorized by the Board or the Convention.
- 4. A majority of the committee shall constitute a quorum after every member has been notified sufficiently in advance.
- 5. The administrative committee shall serve as the budget and audit committee for the Convention and shall meet with the executive director-treasurer to prepare the budget which is to be presented to the executive board in its September meeting and then the Board shall present the budget to the Convention in its annual session.

ARTICLE XI, ALTERATIONS

Any alterations may be made in these articles by a vote of two-thirds of the members present when the vote is taken without regard to the total enrollment at any annual meeting of the convention, provided that:

- 1. Any proposed amendment shall be presented in the book of reports and read on the first day of the Convention.
- 2. An amendment shall become effective upon approval by two successive Conventions.
- 3. The Bylaws may be changed by a simple majority vote in Annual Meeting.

Bylaws Bylaw I – Disbursements

- 1. All Cooperative Program receipts to the Convention shall be disbursed according to percentages or amounts approved by the Convention in its annual budget.
- 2. Special gifts shall be applied according to the instructions of the donors in keeping with charitable contribution laws and the guidelines of the executive board and agency trustees.
- 3. Undesignated gifts may be applied as the Convention wills.
- 4. The treasurer(s) of the Convention funds and institutions shall be bonded for faithful performance of duty, said bond(s) to be approved by the administrative committee of the executive board.

Bylaw II - MEETINGS

- 1. The Convention shall choose its meeting times and place.
- 2. The administrative committee of the executive board, when sufficient emergency arises as to time or place, may change the annual meeting either as to time or place or both.
- 3. Special meetings of the Convention shall be called by the president upon approval of the administrative committee. Those present, after at least a thirty-day notice has been presented by the president, shall constitute a quorum.
- 4. The Convention shall use the current edition of Roberts Rules of Order to guide its parliamentary procedures. A parliamentarian may be appointed by the president of the Convention.

Bylaw III - CONVENTION COMMITTEES

1. Committee on Committees:

- a) Purpose: This committee shall serve to nominate members of those committees specifically related to the Convention. These committees shall include a Credentials Committee, Program Committee, Executive Board Nominating Committee, Constitution Review Committee, History Committee and other continuing committees created by the Convention.
- b) Functions: Nominations for members on these committees, including a stipulation of which member shall be chair, shall be presented at the last session of the annual meeting of the Convention. After opportunity for nominations from the floor, these committees shall be elected by the Convention and shall serve from the conclusion of that Convention meeting.
- c) Composition and Selection: This committee of five (5) members shall be appointed by the president at the last session of the Convention and shall begin serving at the close of that session. Members shall be appointed for one year. The president shall stipulate which person shall serve as chair.

2. Credentials Committee:

- a) Purpose: This committee shall serve as the registration committee for the Convention's annual meeting.
- b) Function: As the Convention's registration committee during the annual meeting of the convention, this committee shall organize necessary procedures to effect the orderly certifying and seating of messengers.

All questions of registration of messengers shall be referred to this

- committee. This committee shall make reports to the Convention as to numbers of messengers and guests registered.
- c) Composition and Selection: There shall be five (5) members of this committee on a rotating basis with members elected annually for three years.

3. Program Committee:

- a) Purpose: This committee shall plan and recommend the program for the annual meeting of the Convention.
- b) Function: This committee shall plan the next annual program sufficiently far in advance that provisional programs can be publicized to the constituency not less than one month before the scheduled meeting of that Convention. This committee shall recommend to the Convention the date and place of meeting for the next two (2) years. Previously published dates and places shall be used except when special reasons for changing are noted and approved by the Convention or the Executive Board.
- c) Composition and Selection: This committee shall be composed of five(5) members elected to serve one (1) year.

4. Executive Board Nominating Committee:

- a) Purpose: It shall be the purpose of this committee to nominate members of the executive board, stipulating upon which of the three (3) committees they shall serve. It shall also be the responsibility of this committee to nominate the members of the Baptist Foundation Committee.
- b) Function: Annually, seven (7) members shall be nominated for three (3) years for each of the three (3) committees of the executive board, in addition to the filling of vacancies. The committee shall nominate two (2) members each year for a three (3) year term for the Baptist Foundation Committee. The primary consideration of this committee shall be that those persons being nominated shall have special abilities or expertise that equips them to serve effectively in the area of their specified committee. An effort shall be made to see there is geographical representation as well as a balance between ministers and lay persons, and between male and female. Such concern for balance; however, shall not override concern for electing persons with skills to serve on the various committees. (Article VII, Executive Board)
- c) Composition and Selection: This committee shall be composed of six (6)

members serving on a rotating basis, with two (2) elected annually for three (3) years.

5. Baptist Foundation Committee:

- a) Purpose: It shall be the purpose of this committee to serve the Baptist Convention of Iowa by receiving assets to be held and invested for the purpose for which they are received, i.e. scholarships, loan funds, mission funds. (Article II Section 2)
- b) Function: This committee shall receive and invest assets with the Executive Director-Treasurer serving as Chief Executive Officer working with the committee to serve Baptists in Iowa and the causes of Christ.
- c) Composition and Selection: This committee shall be composed of six (6) members serving on a rotating basis with two (2) being elected annually for a three year term. A member shall serve no more than two (2) three year terms until the lapse of at least one year. The members shall be nominated to the Convention by the Executive Board Nominating Committee.

6. Constitution Review Committee:

- a) Purpose: This committee shall review the constitution and by-laws for needed updating and revising, and shall receive referrals from the Convention.
- b) Function: This committee shall review the constitution and by-laws to be certain it is in harmony with the corporation charter and is consistent with all procedures and practices adopted by the Convention. This committee shall review and report to the executive board all motions for revision presented during the annual meeting of the Convention and/or to the executive board, with evaluations and recommendations ultimately being made to the Convention. This committee shall assist any messenger in presenting motions for revision to assure he shall be acquainted with proper procedures for amending the constitution and by-laws.
- c) Composition and Selection: This committee shall be composed of six (6) members serving on a rotating basis, with two (2) elected annually for three (3) years.

7. History Committee:

a) Purpose: This committee shall be responsible for accumulating, indexing, and communicating to our constituency information about our

history.

- b) Function: This committee shall bring to the attention of the Convention occasions when anniversaries or special events need to be commemorated. It shall print in the annual publication brief, updated digests of the history of the Baptist Convention of Iowa.
- c) Composition and Selection: This committee shall be composed of three (3) members serving on a rotating basis with one (1) elected annually for three (3) years.

8. Baptist State Paper Committee:

- a) Purpose: This committee shall relate to matters pertaining to the <u>Iowa Baptist</u>.
- b) Function: This committee shall meet with the editor and serve as advisory council in matters of the publication of the state paper.
- c) Composition and Selection: This committee shall be composed of three (3) members serving on a rotating basis with one (1) elected annually for three (3) years. The members of this committee shall be nominated by the Committee on Committees.

Introduction

As the Strategy Team met to develop a strategy for the Baptist Convention of Iowa (BCI) it was guided by three underlying principles. 1). The Strategy Team's role was to develop a strategy that will allow BCI to focus on what it will take to reach Iowa for Christ. 2). We understand that if we are to accomplish this task it will take a singular focus that includes developing strong, healthy churches made up of strong, healthy disciples who in turn produce new congregations and disciples. 3). Finally, as Baptists we understand that foundational to who we are, is a strong sense of collaboration reflecting Jesus' prayer in John 17:22b "...that they may be one as we are one..." As such we are making plans for BCI and recommendations to our ministry partners.


This document will lay out the general scope of the strategic plan developed by the Strategy Team (Mike Carlson, Roger Graves, Tom Law, Tim Lubinus, Jim Perkins, Gene Stockton, and Dan Wiersema). This strategy revolves around three concepts: clusters, stack pole churches, and leadership development systems. 1). Clusters are organic groupings of congregations who give each other mutual support through fellowship; help each other develop leaders; and plant new churches. (These may be referred to as associations, networks, areas, etc. They may be linked by proximity (geography), affinity, and/or progeny.) 2). Stack pole (Equipping) churches are congregations who take responsibility for their surrounding community, county, or counties; who actively develop new leaders; and whose pastors understand that in addition to their pastoral duties their principle function is to mentor and equip leaders who can give pastoral leadership to small groups and congregations in the areas that surround the church (Ephesians 4:11-12). 3). Leadership Development Systems (pipelines or "farm clubs") are a natural outgrowth of this process as disciples and potential leaders are mentored; identified and trained; given on-the-job training as small group leaders; and moved out into existing congregations and new church plants.

In the development of the strategy it became obvious that, in order to implement this plan, administrative changes would also be required. The BCI Administrative Team has prepared a separate document which includes many of these changes. As with any change process many changes will not become obvious until other changes have been implemented. As such this will be an ongoing process.

Finally, it will take a concerted effort, working together, and focusing on doing "whatever it takes" to reach Iowa. We, as a fellowship of churches in Iowa, must embrace the changes necessary to reap the harvest of the Great Commission (Matthew 28:18-20).

Plan

The following diagram will help us visualize three things: 1). this is a process that does not end; 2). a person, church, or cluster can enter the process at any point; and 3). there is a lot of overlap because this is a spiral moving us forward, not a circle moving us around.



Key to the development and implementation of this plan is the local church. It grows to a unified effort in the cluster. The role of the BCI is to help chart the course, resource the leaders, encourage those along the way, and provide accountability that, in fact, we are moving in the way that God would have us.

Leadership Development and Discipleship

Central to the success of this strategy is the development of strong healthy stack pole (equipping) churches. We understand that foundational to this process is developing strong healthy Christ-followers and servant leaders in our congregations. Therefore, it is incumbent

on us to develop ways to help churches: disciple those who have come to know Jesus as Savior and Lord; discover those disciples with leadership potential; and invest in these leaders so that they can train others. As we visualize of this concept it might be helpful to think of the high school coach verses a college coach. A college coach searches the nation for the best talent. However, high school coaches must work with what they have. High school coaches who are most successful work with the junior high coaches to identify talented young athletes and equip them to become stars when they reach high school. The very best programs collaborate with those at the elementary school level to help these teachers know how to begin developing young athletes for excellence. Similarly, we seek to encourage the churches in the development of committed disciples and leaders in the pursuit of the Great Commission. The Cluster Facilitator will work with the leadership of the cluster to facilitate this process. Special attention will be given to training and equipping pastors of stack pole (equipping) churches who will equip and mentor the leadership of the small groups and congregations in the surrounding communities.

Church Planting

At the core of the BCI strategy is to start new congregations while strengthening existing ones. Often new congregations impact lostness more effectively than older ones. One reason is that newer churches are aggressively penetrating the edges of darkness. There remains much need for the expansion of Christ's kingdom in Iowa. Forty-eight counties in Iowa do not have any BCI presence. Another 22 counties have smaller congregations and many of these are actually on the geographic edge of the county potentially leaving much of the county unreached. From this perspective, 70 of the 99 counties in Iowa have little or no BCI presence. In addition, many in larger cities have little access to BCI churches. Another statistic would indicate that as much as 77% of the population of Iowa is not part of an evangelical community. That figure may actually be much higher. Therefore we should focus a large part of our resources (time, money, energy, personnel, etc.) on church planting.

Missions

We must keep our eyes focused on the fields that are "white unto harvest" and listen to hear the Spirit calling out those who will minister in those fields. Developing partnerships so congregations can see and participate in what is happening in other places allows us to encourage one another, and learn from one another as we listen to what the Spirit says to the churches. Keeping the focus on the needs, spiritual and physical, both within the State and outside its borders keeps us challenged with the unfinished task and keeps our congregations from becoming inwardly focused. Finally, we must understand that regardless of size and resources every church can engage its community with the love of Christ.

Developmental Goals

- Promote the organic development of church groupings referred to as "clusters" in this document.
- Develop at least one strong healthy BCI congregation in every county in lowa and among every neighborhood of 10,000.
- Assist in developing stack pole churches whose leadership takes responsibility for reaching the surrounding communities.
- Reaffirm the goal of 200 churches by 2020 this would mean one church for every 10,000 people in metropolitan areas (1.1 million divided by 10,000 equals 110) and a church within thirty minutes' drive in the approximately 90 rural, semi-rural, semi-urban counties in lowa.
- Development of a leadership pipeline or farm club which will provide leaders and pastors for the churches and new church plants. This means developing a strategy and process promoting lowans reaching lowa.

The meeting was called to order by President Dan Wiersema at 6:15 pm.

Following a video testimony by Rex Rains prayer was offered by David Miller.

Marion Livingston, Chair of the Credentials Committee, recommended seating the 152 messengers representing 53 churches. He also reported the registration of 8 guests; and recommended that all additional properly credentialed messengers be seated throughout the meeting. The recommendation was approved by voice vote.

The President presented the Program Committee report: recommending the adoption of the program as printed; and that the 2013 meeting be held at the Holiday Inn & Suites on November 1-2, 2013; and November 7-8, 2014 at a location to be recommended by the 2013 Program Committee. The recommendation was approved by voice vote.

The President presented the Executive Board Annual Report. The President asked the Strategy Team consisting of Mike Carlson, Tom Law, Tim Lubinus (absent), Jim Perkins, and Gene Stockton to stand with him (also a member of the Strategy Team) during a powerpoint presentation of the proposed strategy plan. The President presented the proposed constitutional changes, 2013 budget and 2013 calendar with discussion to occur later in the evening and the vote to occur during the Saturday session.

Recommendation of the 2013 Calendar: The President presented the 2013 calendar. Recommendation passed.

Recommendation of the 2013 Budget: The President presented the 2013 budget. Recommendation passed.

Recommendation of Constitutional Changes: David Miller moved that the constitutional changes be considered in three parts: stylistic changes; Article IV, Membership; Article VII, The Executive Board (5). The motion was seconded and passed.

The recommendation to accept proposed stylistic changes passed.

The recommendation to make marked changes to Article IV, Membership passed.

The recommendation to make marked changes to article VI, The Executive Board (5) passed.

Constitutional changes will be presented at the 2013 annual meeting in accordance with Article XI, Alterations (2).

Recommendation of the Strategy Plan. Richard Bettis moved that the strategy plan be voted with written ballot. The motion was seconded and passed. Mitch Green moved that we table the recommendation of the strategy plan until next year's annual meeting. Point of order: a motion was already on the floor(recommendation of the strategy plan). As it may be a violation of order to not give opportunity for discussion before voting, Mitch Green's motion was allowed to be restated. The President presented the Committee on Committees report, and appointed the Administrative Committee to serve in the coming year as the Committee on Committees. Recommendation passed.

LifeWay representative, Stephen Drake, presented President Wiersema with a gift of appreciation.

Jon Jamison shared about the history of the Iowa / Tennessee Partnership and introduced Tennessee Baptist Convention representative, Kim Margrave. Kim presented a gift of

appreciation to Tom Law and Iowa to commemorate the ending of the Tennessee-Iowa Partnership. Jon Jamison, Baptist Convention of Iowa Tennessee Partnership coordinator, presented a plaque of appreciation to Kim Margrave. It was noted that this is not a total end to the partnership, as the friendships made from the work done together will continue between churches from both conventions.

During the Executive Director's Address, Tom Law requested Joni Wilkinson, Iowa WMU Executive Director, assist him in presenting a certificate to Jay Hardymon, Immanuel Baptist Church, Cedar Rapids for the largest single contribution of \$3,306.20 to the State Missions Offering. A certificate was accepted for Journey Fellowship, Council Bluffs by Wes Jones for the largest per capita giving to the State Missions Offering.

Marion Livingston, Chair of the Credentials Committee, brought the Committee's final report: 157 messengers representing 54 churches, and 49 registered guests.

The Tennessee Ladies Chorus, led by Paul Clark, led in worship.

The Annual Sermon was given by Jeff Iorg based on Acts 11:22-26.

The President closed the meeting, and closed in prayer at 11:04 a.m.

Presentation of the Minutes

Minutes of the February 18, 2012 were presented in print and were received as presented.

REPORTS

- A. Partnership agreement (covenant agreement) We have received version 7 of this document. The Administrative Team will review this document in August and will bring a recommendation at the September Executive Board meeting.
- **B.** Collaboration Meeting Dan Wiersema, Gene Stockton, David Barton and Tom Law met with MN/WI and ND/SD leadership in March in Sioux Falls. The discussion with these state leaders has moved from speaking of 'merging' to 'collaborating'. There has been some discussion about beginning a joint venture to work on the I-29 corridor – possibly getting a national missionary to focus on this corridor. Preliminary conversations with Illinois have begun about collaborating along the IA/IL border.

C. Communications

- 1. Database We are continuing to expand our database. Access ACS will allow us to do on-line registration and eventually on-line giving.
- 2. Website Iowa Baptist archive is now online. We are beginning to put additional news items on the website.
 - 3. Iowa Baptist We are beginning to offer a PDF version of the Iowa Baptist to individuals.

- **D. ACP Report** 100% of BCI churches submitted reports for 2011. An ACP Report summary is found on page 52-53 of the 2011 Annual which was distributed to board members.
- **E. Search Team** The search team met February 18, 2012 Consensus was to wait to begin meeting until early in 2013. This will allow a new strategy to be developed this year. Once the strategy is in place, then the search team can discuss a profile needed for an executive director. After the profile is developed, the team can begin publicizing the profile and receiving resumes.

F. Financial Report

- **1. Year To Date** A comparison of Cooperative Program, Annie Armstrong, Lottie Moon and Iowa Missions was presented. It is projected that we will have \$50,000 less in CP giving this year than last.
- **2. Audit** The audit has been completed. The auditor did not find anything to question this year. He stated that this was the cleanest set of books he's done here. The auditor suggested the consolidation of some accounts. The following was recommended: 1) the transfer of funds from Account # 81603 Church Starting (\$55,293.43) and half of Account # 81617 Cedar Falls (\$92,606.05) to Account # 81613 Barnes New Work and 2) transfer the other half of Account #81617 Cedar Falls (92,606.00) to Account #10886 McFerron Allocation for office expenses.
- **3. Budget Process** June 4th the staff will meet together starting with a zero based budget with no accounts and build a budget from scratch. In the past accounts were based on the way NAMB distributed the money. NAMB is changing their distribution process, which allows us to restructure our budget.

G. Annual Meeting/Minister's Conference

Jeff Iorg, Golden Gate Seminary will be the keynote speaker at the annual meeting. On Friday there will be a pastors/wives lunch at 2:00. Jeff will be sharing on 'the painful side of leadership'. Beginning at 4:00 Ann Iorg will conduct a breakout session for ministry wives. Other breakout sessions being considered are: Logos technology, coaching, prayer. These breakout sessions will be promoted for church leadership as well as pastors.

During the Annual Meeting four testimonies will be given by church planters.

Jeff Iorg will be covering his own expenses.

1. Minister's retreat April 5-6, 2013 – Frank Page has agreed to be the speaker at this event. We are researching motels in the Jordan Creek area. A nominal fee will be charged.

H. Executive Board resignations –

Jeff Wheeler sent a letter of resignation from the Executive Board and Administrative Committee on March 27, 2012 due to his failing health.

Robert Hudson sent an email of resignation from the Executive Board on May 2, 2012 due to him moving out of state.

Gary Fry would like to resign as chairman of the Church Health Committee. Tommy Rucker is the vice-chairman of this committee, so will be assuming the role of chairman.

I. Executive Director's Evaluation – The Administrative Team has performed an evaluation via email. President Dan Wiersema is reviewing/compiling these evaluations. Because of the many roles that Tom has been fulfilling, his compensation package will be reviewed.

STRATEGY

In April 2011 a listening session was held to talk about where we are and where we need to go as a state convention. During this same time frame, BCI began getting information from NAMB that they were in

the process of change. In the fall of 2011 Executive Director Tom Law began evaluating this material, learning about Iowa, talking with people across the state as well as other judicatory leaders. In March 2012 the seven member strategy team approved by the Executive Board February 18, 2012 developed a proposed Strategy Plan for the Baptist Convention of Iowa. May 21, 2012 a series of town hall meetings will begin being held across the state throughout the spring/summer. In August the strategy team will review the input gleaned from the town hall meetings. Any changes to the document will be presented to the Administrative Committee for approval. The final document will be presented to the Executive Board in September.

A. Report

Dan Wiersema presented the proposed Strategy Plan for the Baptist Convention of Iowa.

2. Administrative Document

Tom Law presented the document entitled 'Changes 5/19/12'. If the Executive Board decides to pursue these changes, it would require some constitutional changes. These proposed changes will be presented during the September Executive Board meeting.

3. Timeline

Tom Law presented a 'phase in – timeline' which serves as a chronological roadmap for the implementation of the proposed strategies.

4. Budget Forecast for 2013, 14, 15 -

Tom Law presented a budget forecast for 2013, 14, 15. This is not an actual budget, just a forecast of what income/distributions might look like.

Presentation of the Minutes

Minutes of the May 19, 2012 were presented in print and were received as presented.

Financial Reports

The August balance sheet was distributed. To date expenses are well under income. Cooperative program giving is up over 6 % from last year.

Phyllis Hoth has been dismissed due to financial considerations. Discussion followed.

Annual Meeting/Minister's Conference Program

A Ministers and Wives Luncheon will be held from 1:00-2:30 p.m. on Friday, November 2nd featuring guest speaker Jeff Iorg, president of Golden Gate Baptist Theological Seminary. A pastors and wives conference/retreat is being planned for April 5-6, 2013 featuring Frank Page. It is anticipated that pastors will pay approximately \$50 per couple for the retreat.

Town Hall Meeting Report

Tom Law reported that there was good attendance and participation during the series of Town Hall Meetings that were held throughout the spring and summer to explain the proposed strategy plan and gain input from individuals through the state.

Staff Report

Tom Law expressed his appreciation for the staff during this time of transition. Staff have been encouraged to work smarter, hot harder by using technology more often and effectively.

It was reported that the LifeWay funding that is provided to BCI is not contigent on a person, but rather on a ministry. This funding will continue to be used for leadership development, training opportunities, etc. There are still resources available for loan from the BCI office.

If the strategy plan is adopted, a phase-in time of 2-3 years is expected.

2013 Calendar

The 2013 calendar was approved as presented.

2013 Budget

Tom Law explained that 75-80% of the BCI budget is designated by donors and how they want their money spent.

In 2012 the projected Cooperative Program giving is \$500,000. \$400,000 of this amount will be kept in the state.

Previously our matching fund percentage was 89/11. We just received notice from NAMB that our new matching percentage will be 95/5 and will remain at that level until we get to the level of keeping \$500,000 in the state.

David Miller made a motion to table the vote on the proposed 2013 budget until after the discussion and vote on the Proposed Strategy Plan. The motion was seconded by Art Cutshall. Motion carried.

Nominating Committee/Committee on Committees

David Miller made a motion to strike the officer nominations from the Nominating Committee/Committee on Committee report. The motion was seconded by Mitch Green. Motion carried as amended.

NAMB Cooperative Agreement

David Miller made a motion to authorize the Executive Director to sign the Strategic Partnership Agreement as presented. The motion was seconded by Bob Stout. Motion carried.

Strategy Plan 9.22.12

Tom Law presented a powerpoint presentation explaining the proposed Strategy Plan. Changes were made to the Strategy Plan document following the Town Hall Meetings. The definition of a Cluster was refined. The title of equipping churches (Eph. 4:11-12) was added to the stackpole churches section.

It was suggested that during the presentation at the Annual Meeting the reasons for why change is needed should be emphasized. This strategy will not be an immediate change, but rather will be phased-in.

A recommendation was given from the Administrative Team to accept the Proposed Strategy Plan (9.22.12). A verbal vote was taken and ruled in favor. A request was made for a show of hands in order to register the count of votes. Seven approved the Strategy Plan, four opposed, three abstained. Motion carried.

2013 Proposed Budget

The 2013 proposed budget was approved.

Proposed Constitutional Changes

ARTICLE IV

An amendment was recommended by Tommy Rucker, second by Bob Stout to add a description in item #4 "(Cooperative Program and/or State Missions Offering)"

Amendment carried.

All other proposed changes to Article IV were approved.

ARTICLE V

A motion was made by Dan Doolin, second by Bob Stout to reinstate the office of 2nd vice president, and all corresponding changes. Motion carried.

No changes were made to Article V from the current constitution.

ARTICLE VI

Only stylistic changes were proposed in Article VI. Changes approved.

ARTICLE VII

Article VII, item 5 will read: When vacancies occur between annual meetings of the convention, these may be filled upon recommendation of the Administrative Committee and a two-thirds vote of the Executive Board present and voting. Change approved.

A motion was made that other than previously approved changes to the constitution and stylistic changes, no other changes be considered until the Constitution Review Committee has a chance to meet.

Staff Recognition

At the conclusion of the meeting Mike Roberts was recognized with a service pin and monetary gift for 5 years of employment. Joni Wilkinson and Wes Jones were recognized for 5 and ten years of service respectively, although they were unable to attend.

Report of the Programs of Work

Annual Report to the 2012 Annual Meeting of the Baptist Convention of Iowa

Thomas L. Law, III, Executive Director-Treasurer

"So Jesus said to them again, "Peace *be* with you; as the Father has sent Me, I also send you...Receive the Holy Spirit." John 20:21-22 "...you will receive power when the Holy Spirit has come upon you; and you shall be My witnesses both in Jerusalem, and in all Judea and Samaria, and even to the remotest part of the earth." (Acts 8:1) "Go therefore and make disciples of all the nations, baptizing them in the name of the Father and the Son and the Holy Spirit, teaching them to observe all that I commanded you; and lo, I am with you always, even to the end of the age." (Matthew 28:19-20)

I. Work Started

Acts 11:19-21"So then those who were scattered because of the persecution that occurred in connection with Stephen made their way to Phoenicia and Cyprus and Antioch, speaking the word to no one except to Jews alone. But there were some of them, men of Cyprus and Cyrene, who came to Antioch and *began* speaking to the Greeks also, preaching the Lord Jesus. And the hand of the Lord was with them, and a large number who believed turned to the Lord."

- A. The early Christians left the known (Jerusalem) for the unknown (Antioch).
- B. "The Fairview Baptist Church, located at Fairview, Iowa, a rural village 4 miles southwest of Anamosa, was the nucleus of the Southern Baptist Work in Iowa. The church was organized with 16 members on June 12, 1954, under the direction of Rev. Bruce Maples, Director of the Office of Missions of Jefferson City, Missouri. However, the church had its beginning in the home of Rev. and Mrs. Harry B. Eales, Marion, Iowa. Sunday school, worship service, and mid-week prayer meeting were conducted there under the leadership of Rev. Eales for nearly two years before a one-room church building was purchased on the present site in 1953".

II. Progress

Acts13:1-3 "Now there were at Antioch, in the church that was *there*, prophets and teachers: Barnabas, and Simeon who was called Niger, and Lucius of Cyrene, and Manaen who had been brought up with Herod the tetrarch, and Saul. While they were ministering to the Lord and fasting, the Holy Spirit said, "Set apart for Me Barnabas and Saul for the work to which I have called them." Then, when they had fasted and prayed and laid their hands on them, they sent them away."

A. As the work in Antioch grew they sent out Paul and Barnabas to start new congregations.

B. "The first meeting of the one organized church and chapels of Iowa Southern Baptists was held Friday night, February 7, 1958, four miles southwest of Anamose, Iowa – white frame building on the right hand side of highway. The chapels represented: Benton Street Baptist Chapel (Ottumwa, Iowa); Davenport Baptist Chapel (Davenport, Iowa); Lisbon Baptist Chapel (Lisbon, Iowa); Centerville – not present; and Clinton, Baptist Chapel (Clinton, Iowa)".

Acts 18:11 "And he settled *there* a year and six months, teaching the word of God among them."

Paul began training up leaders.

- A. Young Iowans responded to the gospel the Millers went to Taiwan, the Hydes went to the Philippines, the Owens went to Turkey, the Lubinus went to Korea, Mike Carlson, David Miller, etc.
- B. In 1980 the 65 churches in Iowa became a Fellowship of the Missouri Baptist Convention.
- C. In 1995 the Baptist Convention of Iowa was formed with 80 churches.

Acts 18:26 "But when Priscilla and Aquila heard him [Apollos], they took him aside and explained to him the way of God more accurately."

- A. A laywoman (Prisicilla) and layman (Aquila) showed this young preacher boy the truth of the gospel and the result is found in 1 Corinthians 3:6.
- B. "Where we were adding, he [William Hyde] was multiplying.' Hyde did that by training pastors and lay people, equipping others to plant churches, rather than have those efforts depend on him, or on a relative few. Out of the January conference, 1,086 new church planting teams were formed. It is expected each team will plant three churches. Hyde had plans for training 150 Filipinos as trainers next year. And through them, training another 7,000 lay people in church planting. He was a big man with a big vision".
- C. The work in Iowa has grown, but what now...

III. Future

Romans 15: 22-24 For this reason I have often been prevented from coming to you; but now, with no further place for me in these regions, and since I have had for many years a longing to come to you whenever I go to Spain—for I hope to see you in passing, and to be helped on my way there by you,"

Paul was always looking at that next challenge. What about us?

- A. Conversation with Paul Watson about Perspectives
 - a. About a month before the Jimmy Barrentine called to ask if I (Tom Law) would be interested in coming to Iowa to work as the Executive Director I met with Paul Watson. We were exploring how we could help launch Rapidly Reproducing

- Discipleship Movements or what is commonly called a Church Planting Movement (CPM).
- b. He indicated that he that the next Great Awakening or Church Planting Movement in America is going to start in Iowa among other focal points. His reason is that one out of every seven people that have gone through the Perspective classes is from Iowa. Perspective is a course for Christians to help them understand other cultures and worldviews. A number of churches use it to train their people who are going on mission trips.
- c. Obviously, this caught my attention and when Jimmy Barrentine called I said yes. I had been praying for an opportunity to be part of what God is doing to change America and, at least, one Christian leader felt that Iowa is going to be one of those places.

B. Conversations since coming to Iowa:

- a. When I (Tom Law) first came to Iowa the leadership expressed a need for change. Some of this was driven by the need to respond to NAMB changes and some reflecting the realities of our current cultural and financial situations. As the conversation continued (especially with the Strategy Team) we began to focus on what was best for Iowa and reaching Iowa with the Gospel.
- The strategy team outlined three issues on which the Convention needed to focus.
 These are Leadership Development (Discipleship), Church Planting, and Missions.
- c. In Latin America when a boy moves from Primary School to Secondary School the uniform changes from short pants to long pants. Reflecting on this often a young man will be encouraged to "put on his long pants", in other words he will be encouraged to "grow up." I am beginning to hear the feeling among our leadership that it is time for us to take responsibility for our own future and not depend on others. In a sense we are "putting on our long pants".
- d. This was very apparent as the State Missions Offering Team met to plan the offering for next year. Over and over the question was asked, How can we shape the message about the offering so that the people in the congregations will catch a vision for supporting and expanding the work in Iowa and freeing us from dependency on outside resources? What a fabulous goal and vision!
- e. A few months back one of the Directors of Mission said, "Either we have not known about it or this has never happened before". He was talking about the number of people who were moving to Iowa to plant churches or the strengthen those in existence.
- f. As I (Tom Law) went around the State attending the Town Hall meetings I became excited as people told me about what God wanted them to do to expand the Kingdom. Among others:

- i. Develop through their church a training facility to equip bi-vocational pastors.
- ii. Plant, at least, one new congregation each year.
- iii. Develop "Gospel Communities" as a means of developing disciples in their church.
- iv. Start a new congregation with the design for it to be an equipping center that launches new congregations.
- v. Associations taking ownership of their future and not be dependent on outside resources for their leadership.
- g. The Directors of Missions have helped me (Tom Law) understand the difficulties that they have encountered over the years as they have tried to expand the Kingdom through church planting in Iowa. One issue they have faced is finding sponsoring congregations who are willing to take ownership of the new church plants. Another is the difficulty in finding qualified people that are willing to come to Iowa to plant churches. All of this seems to be changing.
- h. While in 2011/2012 there were 7 or 8 church plants with which we are working, there are now about 18 new church plants that are in some stage of development. I would like to just mention a few.
 - i. Cody Hinton was the youth minister at First Grace in Sheffield. He went to Midwestern and has been working with a church in St. Joseph Missouri. He now feels God wanting him to plant a church in Council Bluffs. He has been working for Home Depot. They will allow him to transfer to the Council Bluffs site so that he can continue working while he gathers a core group for the new church plant.
 - ii. A young man from the South, who married a young woman from Hull, settled in northwest Iowa. He is fluent in Spanish and feels that God wants to use him to start Hispanic churches in the Siouxland. He has started a Bible study at his work with 27 fellows employees. He has begun preaching in the churches in the area casting a vision for how God wants to open the Gospel to this growing population segment.
 - iii. A church that had not started a new church in its first fourteen years of life, come early next year will have started four in four years.
 - iv. A Korean layman from Atlanta is seeking God's will to start a Korean congregation among people, in Iowa, with whom he works.
 - v. A young man and his wife, who grew up in the greater Des Moines area, after going away to school are back seeking God's will to either pastor an existing congregation or launch a new church.
 - vi. A young man and his wife continue to sense God's call to ministry even after the door was closed to them going as pastor to an existing congregation. They are convinced that God is calling them back to

Webster City from where they came. David Barton, Rolling Hills Baptist Church in Fort Dodge, has been praying for two years about starting a new church in Webster City. God is stirring the hearts of young people from Webster City who are going off to college and they are looking forward to being involved in The SALT Company when they get there. Teams of volunteers from Tennessee worked in Webster City and as a result gathered the names of 800 contacts. The young couple from Webster City, convinced that God still want them in ministry make plans to move to Webster City unaware of what all else God has been doing.

- vii. A new church is planted in Indianola with the vision of reaching what has become a secular campus, Simpson College. Although the pastor of the new church plant was prohibited from going on campus and the students were told they could not have Bible studies on campus God opened the way. A Friends church one block away from the college campus, on the verge of closing their doors, sensed that God still had something important for them to do. When asked they opened their door to the new church plant's Wednesday night service and band practice. They also are allowing the new church plant to hold their Thursday night student meetings in the building. Forty students are attending Thursday nights and these students have begun going to the campus to hold Bible studies.
- i. Partnerships with churches and associations in other states are developing rapidly and have great promise.
- j. A church that has been struggling for years has agreed to sell their property and give the proceeds to the Baptist Convention of Iowa to create an endowment fund to help start new churches across Iowa.
- k. It is amazing to see how God is putting all of the pieces together.
- 1. The list goes on. God is doing a marvelous work in this State. He is blessing us and giving us a tremendous opportunity to expand His Kingdom. It is our responsibility to join Him in His work and do what He has asked us to do.
- m. The questions each of us has to ask is: "What about me? What does God want me to do in His Kingdom? What is holding me back from doing what God wants in my life? What am I going to do about it?

Baptist Convention of Iowa CONSTITUTION AND BY-LAWS

ARTICLE I, NAME

The name of this body is Baptist Convention of Iowa.

ARTICLE II, PURPOSE

It shall be the purpose of this Convention to offer an Agency of Cooperation for the churches and missions, to promote the preaching of the gospel in Iowa and throughout the world, to support ministerial and Christian education, to organize and promote all phases of work fostered by this Convention and the Southern Baptist Convention, and to aid any benevolent or moral movements it may deem promotive of God's Kingdom.

ARTICLE III, AUTHORITY

- 1. The Convention shall have ultimate control of any institutions that have been, or may be, acquired by or originated in this body.
- 2. The Convention shall choose for each institution a board of trustees, in number according to the charter of each institution, and fix their terms of service, reserving the right to change the terms of service of such trustees and to remove from office any and all of them

- at will. Boards of trustees and other agencies shall in everything be subject to the control of this Convention.
- 3. The Convention reserves the right, as plainly implied in the first section of this article, to effect a change in the charter of any of its institutions. Any institution which desires to amend its charter shall submit the proposed amendment in writing to the Convention for its approval, provided that the proposed changes be submitted in writing to the Convention on the first day of its meeting and be voted on the second day.
- 4. Trustees shall make such annual and special reports of their expenditures and of the state of their respective institutions as this Convention may require.
- 5. No trustee shall be paid a salary, fee, or commission by the institution he serves as trustee.
- 6. While independent and sovereign in its own affairs, this Convention recognizes the autonomy of churches and associations and disclaims all right of exercising authority over any church, association or any other Baptist institution not under the management of this Convention.

ARTICLE IV, MEMBERSHIP

The Convention shall consist of messengers who are members of Baptist Churches and Missions cooperating with the Convention selected on either a numerical or financial basis. A cooperating church shall be defined as one participating in and contributing to the causes of the Baptist Convention of Iowa, i.e., cooperative program and missions giving. Each messenger shall be a member of the church which elects him/her.

- 1. On a numerical basis: Two messengers shall be allowed from each cooperating church or mission. of fifty members or less. and one other messenger for every additional fifty members.
- 2. On a financial basis: One additional messenger shall be allowed from each cooperating church or mission for any part of the first two five hundred dollars contributed to the work of the Convention, one additional messenger for the next five hundred dollars above the first two five hundred dollars contributed to the work of the Convention, and one additional messenger for each two five hundred dollars contributed to the work of the Convention above the first seven hundred one thousand dollars.
- 3. The messengers shall be elected and certified by the churches to the Convention with no church having more than ten (10) messengers.
- 4. The records as shown in the last published annual of *The previous year's giving to* the Baptist Convention of Iowa (Cooperative Program and/or State Missions

Offering) shall be used to determine the number of messengers from any one church.

ARTICLE V, OFFICERS

- 1. The officers of the Convention shall be president, a first vice president, a second vice president, a secretary, and a treasurer.
- 2. All officers except the treasurer shall be elected at each annual meeting of the Convention, the president on the evening of the first day and the vice presidents in the same session or the morning session of the second day. Their term of office shall begin at the close of that annual convention.
- 3. The executive director-treasurer elected by the Executive Board of the Convention shall serve as the treasurer of the Convention.
- 4. The term of the office for the president is limited to two years, and he shall not be eligible for re-election until as much as one year has elapsed from the time his successor is named.
- 5. No employee of the Convention, its several institutions, agencies, or programs of work receiving compensation from the convention's budget shall be eligible to serve as president, 1st vice president, or 2nd vice president.
- 6. Officers of the Convention, officers and members of boards of trustees, and members of committees of the Convention shall hold membership in a church affiliated with and in cooperation with the Baptist Convention of Iowa.

ARTICLE VI, DUTIES OF OFFICERS

- 1. **The** President: The duties of the president shall be to preside at all meetings of the Convention and serve as chairman of the Executive Board; while presiding at meetings, maintain order, decide all points of order except those appealed to the body, and to appoint the committee on committees. It shall be the president's privilege to speak as any other person, provided one of the vice presidents has been called to the chair. The president shall serve as ex-officio member of all committees, except when he chooses to ask one of the vice presidents to serve.
- 2. **The** First Vice president shall act in full capacity of president when the president is unable to fulfill the responsibilities or the office is vacant, or when the president chooses to invite the vice president to serve. The first vice president shall serve as ex-officio to the **e**Executive **b**Board.
- 3. Second Vice president shall be available to preside when called upon by the President. The Second Vice president shall act in full capacity of the First Vice president when the First Vice president is unable to fulfill the responsibilities or the office is vacant.

- 4. The Secretary shall record all proceedings of the Convention in session and the eE xecutive bB oard in its meetings. The secretary shall keep a file of the minutes in a fireproof protection. This file constitutes the authentic record of the convention.
- 5. The Executive Director-Treasurer, elected by the eE xecutive bB oard of the Convention, shall serve as treasurer of the Convention.
 - a) The treasurer shall receive and disburse the general and designated funds of the Convention as authorized by the Convention in session.
 - b) He shall have charge of invested and trust funds, invest and disburse the same, collect and disburse interest thereon, subject in both cases to instructions of the convention or of its administrative committee and the eExecutive bBoard.
 - c) He shall make an annual report to the eE xecutive bB oard for its approval and to the Convention for its approval of all receipts, disbursements, expenses, and investments.
 - d) His books shall be audited/reviewed by a certified public accountant. A statement by the auditor/accountant concerning the audit/review and the Convention's business will be published in the minutes.
- 6. The President, First Vice president, and Secretary shall constitute the Executive Officers of the Executive Board and shall have all the powers formerly entrusted to Trustees. However, nothing in this Constitution shall be deemed to require said Executive Officers to be held to the same legal standard as a Trustee to the extent that such legal standards exceed those that would be applicable to a corporate officer.

ARTICLE VII, THE EXECUTIVE BOARD

At the annual meeting the Convention shall nominate and elect an eE xecutive bB oard of the Baptist Convention of Iowa.

- 1. The **e***E* xecutive **b***B* oard of the Baptist Convention of Iowa shall consist of 21 regular members plus the president, first vice president, and secretary. One third shall be elected each year to serve a three-year term.
- 2. Two members shall be chosen from each association.
- 3. There shall be seven members chosen as at-large members which will properly represent more heavily populated areas of the state.

- 4. An effort shall be made to ensure balance between pastors and laity, and between male and female; however, the primary consideration for selection of *eE*xecutive *bB*oard members shall be their expertise to serve effectively.
- 5. When vacancies occur between annual meetings of the convention, these may be filled upon recommendation of the executive board nominating committee *Administrative Committee* and a two-thirds vote of the executive bBoard present and voting.
- 6. All members of the **b***B*oard shall be members in good standing of Baptist churches which cooperate with the Convention in its programs of work and the Cooperative Program.
- 7. A member shall be elected for a term of three years and may be re-elected for a second three-year term. After a lapse of one year he may serve again if elected.
- 8. Nominees shall hold membership in a BCI affiliated church within the ministry area of an association at least one year before being eligible to serve on the Convention's eExecutive bBoard. Persons moving from an association or at large area to another shall vacate their position on the Board.
- 9. Members of the Executive Board may be removed in accordance with the Articles of Incorporation, Article IX.

ARTICLE VIII, DUTIES OF THE EXECUTIVE BOARD

- 1. The **e**Executive **b**Board shall be the executive, administrative, and promotional agency of the Convention and shall act under the instructions of the Convention, acting in its own capacity as a body through its administrative committee.
- 2. The **e***E*xecutive **b***B*oard shall recommend to the Convention both a proposed goal or objective for raising funds, and a proposed distribution. The **b***B*oard shall promote all missionary, educational and benevolent causes of the Convention, and receive and disburse all funds according to the annual budget adopted by the Convention.
- 3. The eE xecutive bB oard shall have authority to act, as a body or through its administrative committee, in all matters committed to it by the Convention and in matters which may arise between Convention sessions.
- 4. With the exception of the state office building, the eE xecutive bB oard shall have authority to purchase, sell or lease property and to incur indebtedness necessary for the operation of the Convention. The state office building shall not be sold or leased without the approval of the messengers in an annual or called meeting.
- 5. It shall be the specific duty of each member of the b*B*oard to promote the Convention's program in his/her respective area of the state.

6. A majority of the Board shall constitute a quorum after every member has been notified sufficiently in advance.

ARTICLE IX, THE ADMINISTRATIVE COMMITTEE

- 1. The Convention shall elect the **e***E*xecutive **b***B*oard annually. The president, first-vice president, secretary and executive director-treasurer the chairpersons of the **b***B*oard's standing committees shall serve as the Convention's administrative committee. The standing committees are: Evangelism and Ministries Committee, Missions Committee and Church Health Committee. Standing committees may be changed, added or deleted at the discretion of the *eE*xecutive **b***B*oard. The past president shall serve as exofficio for one year following his term as president.
- 2. The president of the Convention shall serve as president of the **a**Administrative **e** Committee and the recording secretary shall serve as secretary.
- 3. Members of the administrative committee shall not receive compensation from the Convention budget, nor may members of their immediate families.

ARTICLE X, DUTIES OF THE ADMINISTRATIVE COMMITTEE

- 1. The administrative committee shall act under the authority of the eExecutive bBoard and/or the Convention in any matter committed to it by the bBoard or by the Convention.
- 2. The committee shall act on any emergency administrative matter and its action shall carry the authority of the Convention, subject to review by the eExecutive bBoard.
- 3. The committee shall not involve the Board nor Convention in financial obligations or project any major plans or work not authorized by the Board or the Convention.
- 4. A majority of the committee shall constitute a quorum after every member has been notified sufficiently in advance.
- 5. The administrative committee shall serve as the budget and audit committee for the Convention and shall meet with the executive director-treasurer to prepare the budget which is to be presented to the eExecutive bBoard in its September meeting and then the Board shall present the budget to the Convention in its annual session.
- 6. The Administrative Committee shall serve as the resolutions committee of the convention while the convention is in session. [November 2008].

ARTICLE XI, ALTERATIONS

Any alterations may be made in these articles by a vote of two-thirds of the members present when the vote is taken without regard to the total enrollment at any annual meeting of the convention, provided that:

- 1. Any proposed amendment shall be presented in the book of reports and read on the first day of the Convention.
- 2. An amendment shall become effective upon approval by two successive Conventions.
- 3. The Bylaws may be changed by a simple majority vote in Annual Meeting.

Bylaws

Bylaw I – DISBURSEMENTS

- 1. All Cooperative Program receipts to the Convention shall be disbursed according to percentages or amounts approved by the Convention in its annual budget.
- 2. Special gifts shall be applied according to the instructions of the donors in keeping with charitable contribution laws and the guidelines of the **e***E*xecutive **b***B*oard and agency trustees.
- 3. Undesignated gifts may be applied as the Convention wills.
- 4. The treasurer(s) of the Convention funds and institutions shall be bonded for faithful performance of duty, said bond(s) to be approved by the administrative committee of the **e***E*xecutive **b***B*oard.

Bylaw II – MEETINGS

- 1. The Convention shall choose its meeting times and place.
- 2. The administrative committee of the eExecutive bBoard, when sufficient emergency arises as to time or place, may change the annual meeting either as to time or place or both.
- 3. Special meetings of the Convention shall be called by the president upon approval of the administrative committee. Those present, after at least a thirty-day notice has been presented by the president, shall constitute a quorum.
- 4. The Convention shall use the current edition of Roberts Rules of Order to guide its parliamentary procedures. A parliamentarian may be appointed by the president of the Convention.

Bylaw III - CONVENTION COMMITTEES

- 1. Committee on Committees:
 - a) Purpose: This committee shall serve to nominate members of those committees specifically related to the Convention.
 - b) Functions: Nominations for members on these committees including

a stipulation of which member shall be chair, shall be presented at the last session of the annual meeting of the Convention. After opportunity for nominations from the floor, these committees shall be elected by the Convention and shall serve from the conclusion of that Convention meeting.

c) Composition and Selection: This committee of five (5) members shall be appointed by the president at the last session of the Convention and shall begin serving at the close of that session. Members shall be appointed for one year. The president shall stipulate which person shall serve as chair.

2. Credentials Committee:

- a) Purpose: This committee shall serve as the registration committee for the Convention's annual meeting
- b) Function: As the Convention's registration committee during the annual meeting of the convention, this committee shall organize necessary procedures to effect the orderly certifying and seating of messengers.
 - All questions of registration of messengers shall be referred to this committee. This committee shall make reports to the Convention as to numbers of messengers and guests registered.
- c) Composition and Selection: There shall be five (5) members of this committee on a rotating basis with members elected annually for three years.

3. Program Committee:

- a) Purpose: This committee shall plan and recommend the program for the annual meeting of the Convention.
- b) Function: This committee shall plan the next annual program sufficiently far in advance that provisional programs can be publicized to the constituency not less than one month before the scheduled meeting of that Convention. This committee shall recommend to the Convention the date and place of meeting for the next two (2) years. Previously published dates and places shall be used except when special reasons for changing are noted and approved by the Convention or the Executive Board.
- c) Composition and Selection: This committee shall be composed of five (5) members elected to serve one (1) year.

4. Executive Board Nominating Committee:

- a) Purpose: It shall be the purpose of this committee to nominate members of the **e***E*xecutive **b***B*oard, stipulating upon which of the three (3) committees they shall serve. It shall also be the responsibility of this committee to nominate the members of the Baptist Foundation Committee.
- b) Function: Annually, seven (7) members shall be nominated for three (3) years for each of the three (3) committees of the **e**Executive **b**Board, in addition to the filling of vacancies. The committee shall nominate two (2) members each year for a three (3) year term for the Baptist Foundation Committee. The primary consideration of this committee shall be that those persons being nominated shall have special abilities or expertise that equips them to serve effectively in the area of their specified committee. An effort shall be made to see there is geographical representation as well as a balance between ministers and lay persons, and between male and female. Such concern for balance; however, shall not override concern for electing persons with skills to serve on the various committees. (Article VII, Executive Board)
- c) Composition and Selection: This committee shall be composed of six (6) members serving on a rotating basis, with two (2) elected annually for three (3) years.

5. Baptist Foundation Committee:

- a) Purpose: It shall be the purpose of this committee to serve the Baptist Convention of Iowa by receiving assets to be held and invested for the purpose for which they are received, i.e. scholarships, loan funds, mission funds. (Article II Section 2)
- b) Function: This committee shall receive and invest assets with the Executive Director-Treasurer serving as Chief Executive Officer working with the committee to serve Baptists in Iowa and the causes of Christ.
- c) Composition and Selection: This committee shall be composed of six (6) members serving on a rotating basis with two (2) being elected annually for a three year term. A member shall serve no more than two (2) three year terms until the lapse of at least one year. The members shall be nominated to the Convention by the Executive Board Nominating Committee.

6. Constitution Review Committee:

a) Purpose: This committee shall review the constitution and by-laws for needed updating and revising, and shall receive referrals from the Convention.

- b) Function: This committee shall review the constitution and by-laws to be certain it is in harmony with the corporation charter and is consistent with all procedures and practices adopted by the Convention. This committee shall review and report to the eExecutive bBoard all motions for revision presented during the annual meeting of the Convention and/or to the eExecutive bBoard, with evaluations and recommendations ultimately being made to the Convention. This committee shall assist any messenger in presenting motions for revision to assure he shall be acquainted with proper procedures for amending the constitution and by-laws.
- c) Composition and Selection: This committee shall be composed of six (6) members.serving on a rotating basis, with two (2) elected annually for three (3) years.

7. History Committee:

- a) Purpose: This committee shall be responsible for accumulating, indexing, and communicating to our constituency information about our history.
- b) Function: This committee shall bring to the attention of the Convention occasions when anniversaries or special events need to be commemorated. It shall print in the annual publication brief, updated digests of the history of the Baptist Convention of Iowa.
- c) Composition and Selection: This committee shall be composed of three (3) members serving on a rotating basis with one (1) elected annually for three (3) years.

8. Baptist State Paper Committee:

- a) Purpose: This committee shall relate to matters pertaining to the <u>Iowa Baptist</u>.
- b) Function: This committee shall meet with the editor and serve as advisory council in matters of the publication of the state paper.
- c) Composition and Selection: This committee shall be composed of three (3) members serving on a rotating basis with one (1) elected annually for three (3) years. The members of this committee shall be nominated by the Committee on Committees.

History Committee (Joe Needham-Chair, David Brown, Ross Harmonson) <u>History Committee Report</u>

Joseph Needham, Chair

The past year was a time of considerable adjustment for the Baptist Convention of Iowa. Jimmy Barrentine's retirement and Tom Law's coming as the Interim Executive Director/Treasurer, diminished funding from NAMB, and the replacement of the Tennessee Partnership with a similar relationship with Missouri all contributed to major changes across the Hawkeye State. Thankfully, our Lord is not bound by human constraints and continues His work as the following synopsis attests.

Two churches joined the Convention while none closed or broke fellowship, leaving our number at 101. We are blessed with the following pastors and wives who came, Ken and Lori Barlow relocated to Keokuk's Bethany Baptist in February, Josh and Elizabeth Armendariz joined Cornerstone in Ankeny five months subsequent, and in September Friendship Baptist in Ames called Moses and Breanne Ward. Long-time pastor Max Carmichael retired from Calvary Baptist Church, Leon and Vince Goemaat resigned from New Life in Knoxville.

Some statistics on church attendance, membership, and giving provide insight regarding basic trends.* We had over 400 new additions and slightly more baptisms than the previous year, yet total membership declined by more than 200 to just over 12,700. This was, however, offset in part by an increase of 500 worshippers to nearly 10,600 and a jump of slightly under 875 to a total of 7,400 individuals participating in some type of Bible study. Finances remain challenging as receipts for 2011 totaled \$487,000, nearly \$40,000 less than in 2010 but this year appear to be on track to increase over \$17,000 from our 2011 giving. Nevertheless, we remain at roughly 2006 levels.

More than 50 years after Southern Baptists initially made intentional efforts to evangelize Iowa, we remain a pioneer state. Even so, the Lord remains faithful, and continually provides us with many challenges, to trust Him, obey Him, and allow Him to continue His work among us.

*Not all the information regarding attendance, membership, and giving is drawn from the same time frame, nonetheless, it is the latest available.

Iowa Baptist Committee (Jerome Risting-Chair, Todd Stiles, John Sheeley): The IA Baptist Committee did not meet in 2012. No action was taken.

Baptist Foundation Committee (Mike Carlson-Chair, Joyce Hardymon, Louise Lorenz, Terry Wilkinson, Bob Scott, Ryan Carpenter): The information found in the report as follows is subject to the end of year audit.

Explanation of Funds:

Irene McFerron Small Church Fund: Provides maintenance and repair grants to small churches and missions.

Lindberg-McFerron Scholarship Fund: Provides scholarships for students preparing for ministry.

Non-Interest Bearing Loan Fund: Helps to meet critical needs by providing small non-interest bearing loans.

Kier Memorial Fund: Helps to under-gird the convention's on-going cooperative program budget.

Barnes New Work Fund: Provides funding for starting new churches and new ministries.

Hamilton Collegiate Missions Fund: helps college students engage in North American Mission Board and International Mission Board projects.

The information presented represents current information available on September 30, 2012. Variations in the report would be due to outstanding accrued interest, reclassifying journal entries, and other such information that may arise during the year-end audit. The Baptist Convention of Iowa makes every effort to preserve donor intent for Kingdom purposes.

Missions Report - Church Planting

Thomas L. Law, III

We are moving from mere cooperation to collaboration. This is growing out of an understanding that without interdependency we will not be successful. This is most evident in the reproductive culture that is being developed. Whereas the general perspective a year ago was that church planting was initiated by BCI and the Association, now we are developing a culture in Iowa that understands that reproduction is natural and something every individual believer, church and cluster should be involved in doing. This means people reaching people; groups planting groups; and churches planting churches. This is natural and is becoming the norm here in Iowa.

The most dramatic demonstration of this is the growing list of potential church plants that is developing. These include: Sioux City (two different house church initiatives); a house church initiative in West Des Moines; Hispanic initiatives in Dubuque, Cedar Rapids, Sioux City, Orange City, and Marshalltown; a Nepali initiative in Des Moines; an African initiative in Ames; a Korean initiative in Fort Dodge; partnership church plants with Missouri in Council Bluffs, Oakland, Wright County, Marshalltown, South Des Moines, Montrose and Des Moines; and other plants in Des Moines, Ankeny, Cedar Falls, Cedar Rapids, Webster City, Oskaloosa, Corning, and Dubuque. Although the Associations and the BCI are participating in the development of these initiatives many are growing out of a passion expressed by individuals and churches to reach neighboring communities.

On the display table at the Convention you will find a brochure identifying specific target areas. While we do not want to presume on God and what He is doing in Iowa, it is helpful to highlight areas of greatest need. These include: areas in metropolitan centers; unreached county seat communities; unreached rural areas; unreached ethnic groups; unreached socio-economic groups; and college and university students.

Supporting Iowans to become pastors in Iowa through educational and on-the-job training opportunities is imperative. Training opportunities are being developed or expanded. Church Planting Training Centers are in the process of being developed in Omaha, Sioux City, Dubuque, and Ames. Additionally Church Planting Training Centers which focus on Hispanics are being talked about in Sioux City, Marshalltown, and Cedar Rapids. An equipping center for bi-vocational pastors is being developed in Davenport. Other initiatives that are in process include: small group training; intern and apprentice programs; online and local extension programs for advanced studies;, and underwriting some of the cost for those seeking advanced degrees. Five scholarships each semester have been included in the BCI budget (see Church Health report for the names of the 2012 recepients). Although this is a start we are well aware that this is not enough, therefore, additional funding is being solicited to create an endowment fund to underwrite these educational needs.

Finally, with the Cooperative Program receipt up almost 3% year over year, and with money saved through more efficient use of resources allocated to BCI we have been able to add additional monies to the church planting and leadership development sections of the budget. While we anticipate being able to continue to increase these sections of the budget, the majority of the resources necessary to develop strong healthy new congregations are already in the places where these churches are being established. As is evidenced by the list above, the main support for new church plants in Iowa will come from clusters, churches, and partnerships both inside and outside of the state. We have begun to discover, and must continue to develop the power of

planting groups comprised of several churches which pool financial and material resources. It also involves discovering partners: primary church sponsors, supporting churches and associations.

Being recently transplanted into this state, I have observed (and I am sure that I do not have to tell you) that Iowans are a unique breed. There is a distinctly Iowan way of "going about things" and an underlying attitude and incredible ability to "get what needs to be done with whatever we have". I say this to emphasize that I believe that Iowa can go from depending on outside help; to being able to accept that help; to being a state that is sending help. We must focus on forming and strengthening Iowan "sending churches". These churches send Iowans to reach Iowans. They are Iowan churches planting churches in Iowa. It involves sending nonmonetary resources and short and long term missionaries from Iowa to Iowa.

It is exciting to see how God is already working in Iowa and what He is preparing to do through us. As we discover His initiatives and move alongside Him in this great endeavor, I am continually amazed. He wants to do great things. It is up to us to "grab hold of His coat-tails and hang on" as He takes us where we need to be.

Impact University Report 2012

July 16-21, 167 students and 63 staff spent the week together at Buena Vista University in Storm Lake, Iowa at Impact University; Baptist Convention of Iowa's state youth camp. This camp went into history as our largest so far. Twenty-three of our churches participated, six associations and one church from Minnesota. The theme for Impact this year was "Until the Whole World Hears." We rejoice in the continued faithfulness of our staff and particularly the growing number of former students who are returning to serve as staff each year. Our camp is divided into "schools" Red (youngest), Blue, Green, Orange and Black (more ministry centered training). The schools are broken down into families (usually numbering about 13) for times of discussion, sharing, spiritual formation and relationship building. Our camp pastor this year was *Grant Medford from Church on the Rock, Little Rock, Arkansas* and our worship band, The Corners, returned from last year.

Our administrative staff works tirelessly in preparing for next year's Impact starting with the camp evaluation in the fall and continuing until camp concludes the next summer. Our students and staff do a marvelous job interacting with BVU staff and with the forty or so Japanese students who usually share the campus with us throughout the week. Evangelism takes place not just as a training experience but as a lifestyle throughout the week.

This year 11 students surrendered their lives to Jesus Christ. Several rededicated their lives to the Lord, and other responses to what God was saying throughout the week included: "calls to ministry, commitment of dating lives to godly principles, loving people—with Christ's unconditional love and willingness to obey Christ in baptism."

It is difficult to put down in writing all God does in the lives of staff and students throughout the week of Impact. It is my prayer that we will eventually see at least 50 per cent of our churches participating in Impact and a total staff and student participation of 500. Let's not stop sharing the message of hope in Christ "until the whole world hears."

Church Health Report - Leadership Development and Discipleship

The Great Commission is focused on making disciples. The Epistles are focused on developing disciples and dealing with church conflict. Church history in the book of Acts supports the development of both church planting and church health. Note should be taken that once epicenters like Ephesus and Corinth were established Paul revisited the churches and the Epistles make it clear Paul's strategy was to continue to develop the new churches which had been started in previous trips.

It is important to spend much time, energy and money keeping our base (the established churches) healthy. The established churches provide the resources which allow us to do innovative ministry and church planting within our State. As they mobilize their churches to support each other (identifying needs and opportunities within the existing congregations) the clusters (associations, networks, etc.) are essential elements in keeping the work in Iowa strong. The health of the churches within the cluster depends on the leadership of the cluster. We know that it will be imperative that each cluster identify a champion who will keep fresh the need for mutual support and will help BCI know how to appropriately focus its energies in collaboration with the cluster.

It is important for BCI to help in the strengthening of churches to provide the base for future work in Iowa. Five scholarships, designed to support Iowa students "preparing for full-time Christian Service", have been added to the budget. Ben Perkins (twice), Jonathan Barton, Rebecca Neely, Matthew Deaver, and Jenilee Roddy all received scholarships in 2012.

In addition to scholarships, BCI depends on the leadership of churches and clusters to identify those in their local congregations who would benefit from training. As leadership is developed and strengthened, a congregation becomes healthier. It is then better prepared to send out "ministers" (Ephesians 4:11-12) to penetrate lostness, disciple and equip those who are being reached by the gospel. They become "equipping churches" as reflected in the Ephesians passage. BCI is developing systems to identify these churches, and help them by training and equipping their leadership to mentor others. Some of these will become leaders of small groups in surrounding areas, grow into church planting pastors, and develop equipping congregations of their own.

BCI is a "connector of the wires" between resources and the needs of these equipping churches. BCI does not have all of the resources, but makes every attempt to know where they can be found. BCI is developing a wide-ranging network of partners who will be able to resource and strengthen existing congregations and help launch new congregations.

Central to the success of this strategy is the development of strong healthy equipping churches. Foundational to this process is developing strong healthy Christ-followers and servant leaders in our congregations. Therefore, it is incumbent on us to develop ways to help churches: disciple those who have come to know Jesus as Savior and Lord; discover those disciples with leadership potential; and invest in these leaders so that they can train others. The Cluster Facilitator will work with the leadership of the cluster to facilitate this process.

Evangelism & Pastoral Care Team Leader

Ty Berry, Team Leader

<u>Areas of Responsibility with Volunteer Leaders:</u> Associational Evangelism/Outreach, Men's Ministry Coordinators, Women's Evangelism Leaders, Disaster Relief Volunteer Leadership, Chaplain Leadership, and Pastoral Care Leadership.

We entered the 3nd year of a 10 year commitment called GPS (God's Plan for Sharing) emphasis that embraces (1) Abiding in Christ, (2) Holding to One Another, (3) Reaching out to others. Several churches across Iowa partnered in outreach events that were built around reaching lost people.

<u>Summer and Semester Missionaries:</u> This year 5 summer missionaries from, Missouri, Tennessee, and Iowa served in Iowa churches. It is an honor to invest with these young people coming to serve in mission ministry across Iowa. We had a total of 11 students, including our Semester missionaries, serving in 2012.

<u>Disaster Relief:</u> Our Annual State Wide Training Event was held during the National Roundtable training hosted by Iowa. We had 18 people attending Disaster Relief training this year. We had a small Disaster Response response to the Creston area this year with feeding and chain saw responses. We trained 4 new Disaster Relief Chaplains this year.

Baptisms: Baptisms across Iowa increased slightly this year. A number of churches continued to prayer walk and distributed witnessing materials in their communities. The emphasis for GPS-2013 is HOPE. Our Theme: Reaching Every Iowa Home with Prayer Power called: I-HOPE (Iowa Hope) 2013.-2014.

General Evangelism Training: BCI-Evangelism, partnering with each association to train Iowans in personal evangelism during this year... Each association increased in personal evangelism training from the previous year. Regional Associational Evangelism Conference in each Association helps training and encourages our churches in intentional evangelism. The Baptist Convention of Iowa–Evangelism led 147 people in witness training classes.

Baptist Men/Boys Ministries: Our state-wide men's retreat held at the Y-training Conference Center saw 162 men gather to hear Dennis Pethers from UK. Dennis challenged the men to pray over their communities and model evangelistic outreach.

<u>Leadership Development Network:</u> We saw a continued growth in leadership development through two Leadership workshops. We saw Leadership Development workshop with Pastor Search Committees, deacons, and laymen.

Youth Evangelism/Leadership: Growing number of churches participated in the Ignite Conference for Youth Leadership Training over 1500 in attendance. We handed out over 800 Ecubes and 2000 other witnessing pieces of literature. We witnessed a solid attendance increase

of youth for Impact University (Youth Evangelism/Discipleship week for youth). A growing number of parents and their youth participated in the Prayer Journal, a prayer time for their public schools and administrators.

Literature Distribution: The BCI Evangelism team gave out over 7200 Bibles, 400,900 witnessing tracts, 1600 New Testaments, and host of other training materials designed to equip and educate believers to be intentional in sharing Christ.

Collegiate Ministy Report

The Baptist Convention of Iowa currently helps support four collegiate ministries on five college campuses. These collegiate ministries are led by several churches. Cornerstone at Iowa State, Veritas at the University of Iowa, New Heights at Simpson College, CrossPointe at Drake University and All Nations Baptist Church at the University of Iowa and Grinnell College. These ministries touch and transform lives from around the world. The total number of students participating in these ministries reaches over 2000. This is a sampling of what God is doing in the lives of students reached through collegiate ministry. (For confidentiality purposes I will only use the students' first initial.) J. attended The Salt Company in Ames just 24 hours after trying to end her life. At Salt Co. she heard a message on "joy" and before the night was over she had surrendered her life to the "Joy-Giver." Another student, E. from China, had the parable of the Great Banquet shared with him. Not long thereafter he committed his life to Christ and has been meeting and sharing the message of hope in Christ with other students. A young lady, M. in Iowa City had gotten drunk while visiting another Iowa community and found herself the next morning covered with scrapes and scratches all over her body. Back in Iowa City, a friend invited her to Salt Co. She told her friend that she was tired of living like she was and tired of feeling empty inside. A week later, M. became a child of God. She has been baptized and says, "I have realized life is not about how much money you make or what job you have-it's all in God's hands. I have never felt this much joy."

In 2011-12, over 200 students came to faith in Christ through our collegiate ministries in Iowa. We praise God for the faithful men, women and churches that tirelessly labor in God's field on college campuses in Iowa. Thank you for allowing us to partner in a very small way with what God is doing in a very big way through your ministries!
